With benign submission I, ASI Pradip Singh presently posted to Siliguri PS. SPC beg to state that as per endorsement I made an enquiry in reference to the above and the brief of the fact is that on 04.04.2025 received a written complainant from Mala Sarkar W/O. Nirmal Sarkar of South Bharat Nagar Fuleswari Bazar PS. Siliguri Dist. Darjeeling that from 04.04.2025 (Friday) from 19.00 hrs onwards she found her daughter Nita Sarkar (F/25 yrs) D/O. Nirmal Sarkar who is a brain T.B patient left home for her father's shop but did not return home.

During enquiry I meet the complainant and enquired locally in this regard I also consulted some CCTV footages and collected the CDR of a phone number 7908572552, during investigation it learnt that the cause and nature missing is very much doubtful and there may be a conspiracy behind the disappearance of the missing lady Nita Sarkar (F/25 yrs) D/O. Nirmal Sarkar, one or more may be involved in this matter. Therefore, my humble request is that a specific case may be registered in this matter and arrange for it's investigation.
