In producing herewith arrested accused person namely Bablu sarkar (35 yrs) S/O Late Lakhan Sarkar of Sarbohara Colony, ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles vize i) 15 (fifteen) sealed Plastik Bottles of Himalayan Tuk Tuk 80 up country spirit each containing 600 ml. each , Amounting of Rs 60/- x 15 =RS.900/-) marked as Exhibits-A , ii) 01 (one) sealed Bottle of Bottles of Himalayan Tuk Tuk 80 up country spirit each containing 600 ml., Amounting of Rs 60/- in which was taken out from mother packet box as sample for examination, marked as Exhibits-A1, as per seizure list.

I, ASI Debasish Das of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Bablu sarkar (35 yrs) S/O Late Lakhan Sarkar of Sarbohara Colony, ward No. 28, PS- Siliguri, Dist- Darjeeling to the effect that on 25.04.25 at 22.07 hrs acting on secret source information that the above noted person was busy to sale Id liquor illegally in a open place situated at D.I Fund market, Kala Hati under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no.1193 dated 25.04.25 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Rabin Lama, C/160 Soumen Sarkar both of Siliguri PS left for D.I Fund market Kalahati under Siliguri PS to verify the veracity of the information vide Siliguri PS G.D.E No.1194 dated 25.04.25. On reaching at 22.20 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person, tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the 80 up Country Spirit to locality without any valid documents. On being asked he could not produce any valid documents in respect of the said liquor. On searching vize i) 15 (fifteen) sealed Plastik Bottles of Himalayan Tuk Tuk 80 up country spirit each containing 600 ml. each , Amounting of Rs 60/- x 15 =RS.900/-) marked as Exhibits-A , ii) 01 (one) sealed Bottle of Bottles of Himalayan Tuk Tuk 80 up country spirit each containing 600 ml., Amounting of Rs 60/- in which was taken out from mother packet

box as sample for examination, marked as Exhibits-A1 and accordingly I seized the same as per seizure list as per seizure list as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. He also stated that he is doing this liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 22.35 hrs and 23.05 hrs. As such I arrested him U/S-35(1) BNSS after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Bablu sarkar (35 yrs) S/O Late Lakhan Sarkar of Sarbohara Colony, ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
