In producing herewith the accused person namely Smt. Sanjana Thapa, aged 36 yrs, w/o- Bhupen Thapa, resident of Gowala Busty, Airport more, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Six (06) bottles of Himalayan Gold 60° UP India Made Liquor, each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-A.
 2. Twelve (12) bottles of Tuborg Strong Premium Beer, each contains 650 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B.
- (Total 11.400 ltrs, total value Rs. 2880/-)

I, ASI Amit Lama of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Smt. Sanjana Thapa, aged 36 yrs, w/o- Bhupen Thapa, resident of Gowala Busty, Airport more, PS- Bagdogra, Dist- Darjeeling (not verified) to the effect that on 25.04.2025 at 13:55 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect Smt. Sanjana Thapa at Gowala Busty, Airport more under PS- Bagdogra and the same has been selling illegally. Accordingly, the matter is diarized in GD vide Bagdogra PS GDE No. 1038 dated 25.04.2025 and informed the matter to O/C Bagdogra PS and as per his direction I along with C/1509 Sourav Roy Sarkar, VP/02 Pradip Roy, CV/389 Janak Singh & LCV/210 Jayashree Roy left for Gowala Busty, Airport more to work out the secret source information.

At around 15:50 hrs we reached at Gowala Busty, Airport more and being indication & identification by source we held raid at the house cum shop of the suspect and detained one female person there with the help of accompanying lady Police personnel LCV/210 Jayashree Roy and interrogated her. On interrogation, she revealed her identity as Smt. Sanjana Thapa, aged 36 yrs, w/o- Bhupen Thapa, resident of Gowala Busty, Airport more, PS- Bagdogra, Dist- Darjeeling (not verified) and she introduced herself as the owner of that house cum shop. We disclosed our identity to her and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two independent witnesses namely Kamala Thapa (42), w/o- Late Kumar Thapa and Smt. Sabina Thapa (33), w/o- Purna Thapa, both are resident of Gowala Busty, Airport more were present there as witness. Then, we searched the house cum shop in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from the said house cum shop. On demand, she failed to produce any valid document/license for possessing, stocking & selling that liquor. She confessed that she had been possessing, stocking & selling liquor illegally from her house cum shop since long time for her wrongful gain. Her involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, arrested the involved accused Smt. Sanjana Thapa (as noted above) with the help of accompanying lady Police personnel after observing all legal formalities and communicating her the ground of arrest as she has committed a cognizable offence in presence of Police for possessing, stocking & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 15:50 hrs and 16:20 hrs on 25.04.2025. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Smt. Sanjana Thapa, aged 36 yrs, w/o- Bhupen Thapa, resident of Gowala Busty, Airport more, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
