In producing herewith one arrested person who disclosed his identities Sir, namely Md Bappa (22 yrs) S/O Md Rafikul of Prankrishna Colony, Tikiapra, ward No. 28, PS- Siliguri, Dist- Darjeeling along with the seized articles as per seizure list;

- 1. One improvised one shutter iron made fire arms measuring approx 11 inches from barrel to butt having striking pin, hammer and trigger marked
- 2. One live ammunition engraved O.K 7Z 09 unreadable on its percussion of cap (found loaded in SI No.1) seized exclusively from possession of
- 3. One live ammunition engraved O.K 7Z 09 unreadable on its percussion cap (which was kept concealed in the right pocket of jeens pant of accused Md Bappa) seized exclusively from possession of accused Md Bappa marked as Exhibits-A2

I, Uday Chakraborty of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against Md Bappa (22 yrs) S/O Md Rafikul of Prankrishna Colony, Tikiapra, ward No. 28, PS- Siliguri, Dist- Darjeeling that on 25.04.25 around 20.25 hrs, received a secret source information that one veteran criminal under Siliguri PS, Dist- Darjeeling namely Md Bappa is roaming at P & T Goli, Milanpally, Ward No, 25 under Siliguri PS with an ulterior motive and is in possession of firearms. Diarised the mater vide Siliguri PS GD Entry No. 1183 dated 25.04.25. As per your kind instruction of I/C Siliguri PS, I along with ASI Subir Sen, ASI Rabin Lama, C/160 Soumen Sarkar all Siliguri PS rushed to the place at P & T Goli, Milanpally, Ward No, 25 under Siliguri PS to verify the veracity of this information vide Siliguri PS G.D.E no. 1184 dated 25.04.25.22. Before reaching PO I picked up two disinterested witnesses namely (i) Ashoke Sikder S/O Late Hari Kunja Sikder of P & T Goli, Milanpally, Ward No. 25, PS- Siliguri, Dist- Darjeeling and (ii) Uday Das S/O Sudhir Das of Tikiapara, ward No. 28, PS-Siliguri, Dist- Darjeeling duly informing them about the information in hand. At 20.45 hrs we reached at nearby P & T Goli, Milanpally, Ward No, 25 under Siliguri PS and as per description of the wearing apparels supplied by the source, at 20.55 hrs we found that the above noted person is moving suspiciously at P & T Goli, Milanpally, Ward No, 25 under Siliguri PS. On seeing the police party he tried to escape from the place. But we apprehended the above noted person namely Md Bappa. On being asked, the apprehended person disclosed his identity as noted above. On further interrogation he admitted that he was in the P & T Goli, Milanpally, Ward No, 25 under Siliguri PS with an ulterior motive. Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person Md Bappa was made on search and found that (1) One improvised one shutter iron made fire arms measuring approx 11 inches from barrel to butt having striking pin,

search and found that (1) One improvised one shutter iron made fire arms measuring approx 11 inches from barrel to butt having striking pin, hammer and trigger marked as Exhibits- 'A', (2) One live ammunition engraved O.K 7Z 09 unreadable on its percussion cap (found loaded in SI No.1) seized exclusively from possession of accused Md Bappa marked as Exhibits- 'A1', (3) One live ammunition engraved O.K 7Z 09 unreadable on its percussion cap (which was kept concealed in the right pocket of jeens pant of accused Md Bappa) seized exclusively from possession of accused Md Bappa marked as Exhibits-A2. The Sl. No. 1 was kept concealed under the accused person's waist of his Jeens Pant on the Right side. The ammunition was unloaded from the firearms as per practical experience. On being asked about the possession of the firearms and ammunition, the apprehended Md Bappa made incoherent statements and failed to produce any valid documents in support of said seized Firearms. As there is every reason to believe that the firearms and ammunitions recovered has been procured dishonestly by the apprehended Md Bappa for his ulterior motive, seized and labelled the firearms and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person and arrested him following all formalities. The seizure and label was made in-between 21.05 hrs and 21.46 hrs. On being further asked the arrested accused person admitted that he used purchased the same from Bihar state and sold the same to his design customer for his wrongful gain.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested Md Bappa (22 yrs) S/O Md Rafikul of Prankrishna Colony, Tikiapra, ward No. 28, PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
