I AM SONALI MURMU,D/O- BHAGAN MURMU ,OF
SEBDULLAJOTE,P.O- HATIGHISA,P.S- NAXALBARI,DIST- DARJEELING.

A boy named Ajay Hembram, father not known, sent me a friend request in FACEBOOK and took my phone number and developed a relation with me. Later on 12 April, 2025 he took me to his sister's home at Siliguri near Court More with a promise to marry me. When I refused to go with him, he assured me that he is taking me with him with the intention to marry and within few days he would marry me.

On the night of 12 April, 2025 Ajay raped me against my will at his sister's house at Siliguri. Phone No. of the husband of his sister is 7074296994,7679764937. On the next day on 13 April, 2025 Ajay took me to his home at Satkura, District Jalpaiguri (near Berubari, Bangladesh Border). There he kept me confined for 11 days and snatched my phone so I could not call anyone. Ajay there raped me for several days. He and his mother also tortured me physically and mentally. Then Ajay told me to go home and refused to marry me. On 23 April, 2025 anyhow I managed to call my "Bhabi" and talked to my mother. I stated all the incident to her and requested her to come and save me. Then my mother, my father and 10 family members went to bring me back.

Thus said Ajay Hembram and his mother played with my life and Ajay sexually exploited me with a false promise to marry.

Under the circumstances, I request you to treat this written complaint as FIR, initiate a case against Ajay Hembram and his mother, arrest them and take legal action against them.
