Respected Sir,

With due regards, I, **SMT. NIRMALA VERMA**, Wife of Sri Manish Verma, Resident of S.P. Mukherjee Road, Khalpara, Ward No. 09 of S.M.C., Siliguri, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint before your good authority to the effect that Manish Verma is my legally married husband and after our marriage, I along with my husband have started to reside in the aforesaid address along with my mother-in-law and out of our lawful wedlock, two daughters were born and their names are "Miss. Rishika Verma" (Aged about 23 years) and "Miss. Bhumika Verma" (Aged about 17 years). Sir, we have been residing in the First Floor of a Three Storied building and in the Ground Floor of the said building, my cousin brother-in-law namely Pawan Soni and his family members are residing there.

On 07/04/2025 at about 07.30 P.M., when my younger daughter namely Bhumika Verma went out from the residence and proceeded towards Seth Srilal Market, Siliguri and when she reached near Kedar Math, she met with her two friends and when they were gossiping with each other, my cousin brother-in-law namely Pawan Soni apprehend them and started to abuse and threaten them with dire consequences and after the said incident, my younger daughter left the said place and return back to home.

Immediately after reaching my younger daughter in the house, my cousin brother-in-law namely Pawan Soni accompanied with his wife namely Smt. Santosh Soni and their son namely Sahil Soni have created nuisance in front of our house and they have also started to abuse and threaten me and my family members with dire consequences in absence of my husband and taking advantage of my husband's absence, they have thrown some abusive and vulgar languages towards me and my daughters which tantamounts to modesty of a woman and hearing the same, when I raised my objection against their such type of illegal acts, they became more furious and threatened us with dire consequences by saying that if again my daughter will found and/or talk with any male friends, then

they will not hesitate to teach a good lesson to us. At about 10.00 P.M., when my husband came at home, they have also abused and threatened my husband and on being protest by my husband, they tried to assault my husband physically but somehow, we rescued my husband from their hands.

It is to be mentioned here that on earlier occasion also, they have committed such things with us and police personnel also visited to our house for purpose of enquiry when we informed the matter through 100 dial and we apprehend that in future, they will commit same thing and due to such type of illegal acts and activities, we have been passing our days in extreme fear and mental anxiety for which, some delay has been caused for lodging this written complaint.

I, therefore, request you to kindly investigate into the matter properly after treating my present complaint as an FIR and please take appropriate legal action against the above named persons as per the provision of law and oblige thereby.
