Sub: - Letter of Complaint against of Md. Chand (34yrs) S/O Lt. Md.Lalu of Mazdoor Coloney W/N- 28 PO & PS Siliguri Police Station Dist- Darjeeling. Proprietor of Altab Gas Oven Repairing Centre for illegal refilling of Gas Cylinder.

Sir,

In producing herewith the following seized articles with original seizure list, viz:-

(i) 03(Three) pcs Domestic HP Gas cylinder partially loaded Net weight 14.2 kg, Gross weight 29.6 Kg (approx).

(ii) Total 24 (Twenty four) Pcs of small Gas cylinders (without Brand) in which some partially loaded.

(iii) 04 (Four) pcs Gas Refilling nozzle (metal) which used for gas refilling.

(iv) 02 (Two) Pcs of Slide Range (Iron Made) for use refilling purpose.

I SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against accused person namely Md. Chand (34yrs) S/O Lt. Md.Lalu of Mazdoor Coloney W/N- 28 PO & PS Siliguri Police Station Dist- Darjeeling. to the effect that on 28/04/2025 at about 13:25 hrs received a secrete source information that one Md. Chand of Mazdoor Coloney W/N- 28, Siliguri. is illegally storing, refilling and selling Domestic LPG cylinders at his shop styled as "Altab Gas Oven Repairing Centre" for the purpose of refilling and selling in open market without any valid license or documents for his wrongful gain. Hence I diarized the matter vide EB, SPC GDE No.142 Dt. 28.04.25 and informed the matter to ACP EB, SPC and as per his instruction myself along with Inspector Prosenjjit Das, Inspector Sk Rahataje Noor Nabi, ASI Arghya Das, L/C 1270 Deeptina Gazmer all of EB, SPC left EB Office to proceed Mazdoor Coloney W/N- 28 PO & PS Siliguri Police Station Dist- Darjeeling to execute the information. This refers EB, SPC GDE No.143 Dt. 28.04.25 and C.C. No. 35/25 Dt. 28.04.25.

At about 14:15 hrs we reached at Mazdoor Coloney W/N- 28 PO & PS Siliguri Police Station Dist- Darjeeling and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the shop of "Altab Gas Oven Repairing Centre" and found that the above noted accused person is busy to refilling from the big size HP gas cylinder to small size non branded gas cylinder. On searching, the above noted seized articles have been recovered from his shop. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized articles.

It is crystal clear that the said person namely Md. Chand (34yrs) S/O Lt. Md.Lalu of Mazdoor Coloney W/N- 28 PO & PS Siliguri Police Station Dist- Darjeeling is storing, refilling and selling the Domestic cylinders in his shop for his wrongful gain.

As per local enquiry it came to light that the above noted person refills gas in violation of safety requirements thus conducted negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that local area. Md Chand does not have any valid License/ Permit of dealing /distribution /refilling LPG. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per scizure list in presence of local witnesses namely 1)Bapan Das S/O Samar Das of Prankrishna coloney Deshbandhu Para PS- Siliguri Dist- Darjeeling. 2) Md. Jafar S/O Lt Md Habib Of Mazdoor Coloney W/N- 28 PO & PS Siliguri Police Station Dist- Darjeeling. The seizure was made in between 14:35 hrs to 14:55 hrs.

Hence, I pray that a specific case may be recorded against the accused persons namely Md. Chand (34yrs) S/O Lt. Md.Lalu of Mazdoor Coloney W/N- 28 PO & PS Siliguri Police Station Dist- Darjeeling U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
