Subject: - FIR

Respected Sir,

I, Bipal Agarwal, the sole proprietor of M/s Shri Balajee Logistics, do hereby bring to your immediate and urgent attention a matter of grave criminal concern. On or about 23/04/2025, my vehicle bearing registration number SK08D5151 was unlawfully taken and effectively stolen by a group of individuals who fraudulently posed as recovery agents.

This incident occurred in broad daylight at or around the location known as Ghora More, at approximately 2:00PM. These persons, without any lawful authority, valid documentation, or due process, forcibly took possession of the said vehicle in a manner that constitutes theft, impersonation, criminal intimidation, and a blatant violation of my legal rights.

It is to be made absolutely clear that no prior notice, court order, arbitration award, or repossession decree was ever served upon me, nor was any opportunity given for a lawful resolution or hearing of any alleged financial dues or disputes. The actions of these individuals—who have yet to be positively identified—amount to criminal trespass, extortion, and robbery under the guise of vehicle recovery.

I hereby demand immediate and decisive action from the relevant authorities to Register an FIR under appropriate sections of the against BNS the persons involved Trace and recover the said vehicle without delay, Identify and prosecute the individuals and/or the company that may have orchestrated or authorized this illegal act, Ensure my safety and that of my business assets from any further unlawful actions.
