Sir,

In producing herewith, the 02 (Two) arrested accused person named 1) Md. Rashil @ Racel (23/M), S/o- Samirul Hoque of Kalangini, PS- New Jalpaiguri, Dist. Jalpaiguri, 2) Abbas Ali (21/M) s/o Md. Bachhu of Fulbari Amaidighi, PS- New Jalpaiguri, Dist. Jalpaiguri along with the following seized articles under proper seizure list: -

- (i) One Plastic Packet containing 94.76 grams suspected to be Brown Sugar.
- (ii) Two black and blue colour keypad mobile phone.
- (iii) One red and black TVS NTORQ Scooty having no WB 72V 2277.

I, SI Samik Paul of New Jalpaiguri Police station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted 02 (Two) arrested accused persons to the effect that on 28.04.2025 at about 21:05 hrs, I received a specific source input that two persons coming from Phansidewa side via Mahananda Barrage and will proceed towards Fulbari area with one Scooty having registration No.- WB 72V2277 with huge consignment of suspected to be Brown Sugar for their clandestine disposal. The matter was diarized vide NJP PS GDE No 1920 Dt. 28.04.2025 and I informed the matter to I/C NJP PS and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Nilam Swarnakar, ASI Manoj Majumdar, C/1462 Sajjan Tamang VP 08 Laxman Roy all of NJP PS, Siliguri Police Commissionerate being headed by me left for Gothmabari road near Mahananda Barrage, under New Jalpaiguri PS, Dist.- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 1921, Dated- 28.04.2025 and M.C.C. No. 442/25, Dated-28.04.2025. I also informed the Videographer namely Tapan Manda, S/o-Tusto Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Gothmabari road near Mahananda Barrage, under New Jalpaiguri PS, Dist.- Jalpaiguri to prepare the Video of whole process of search and seizure if any. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to gothmabari I, called two independent witnesses namely (i) Noushad Hossain s/o Mir Musaraf Hossain of West Dhantala, PS- NJP, Dist.- Jalpaiguri and (ii) Saddam Hossain s/o Sk. Rahaman Ali of West Dhantala, PS NJP Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as independent witnesses under relevant provision of law.

At about 21.45 I along with the other officer and force and the witnesses are reached at Gothmabari and after long time being pointed by my source, we saw the scooty having no WB 72 V 2277 coming from Phansidewa side towards Fulbari area. after seeing police party they try to fled away but somehow we managed to intercept the the said Scooty and apprehended the rider & Pillion rider of the Scooty who disclosed their identity as noted above.

After disclosing our identity, we detained the above noted persons with a strong reason to believe that they illegally possessing suspected to be Brown. On being asked they confessed their guilt and admitted that they were carrying the suspected to be Brown Sugar for the purpose of selling the same to their designated customers in order to earn huge money illegally for their wrong full gain. Then I gave them option in writing whether they wanted to be searched in presence of Executive Magistrate or by any Gazetted Officer. The apprehended persons agreed to be searched by Gazzeted Officer. I also offered the apprehended persons to search our Police Party as per provision of law but they denied to search police party.

Accordingly, at about 23:20 hrs I informed the matter to Gazated officer Shri Sonam Lama, Inspector-In-Charge, New Jalpaiguri PS, SPC and requested him to come to the spot and to supervise the whole search and seizure being a gazette officer. Accordingly, at 23.35 hrs. Shri Sonam Lama, Inspector-In-Charge, New Jalpaiguri PS, SPC arrived at the spot and accordingly, I disclosed his identity to the detained persons as Gazated officer. Then In presence of Shri Sonam Lama, Inspector-In-Charge, New Jalpaiguri PS, SPC and other two independent public witnesses we searched the detained persons and found one plastic packet suspected to be brown sugar and two black and blue colour keypad mobile phone both were wrapped with yellow colour plastic which were found inside the dikki of the scotty having no WB72V2277. On demand in presence of Shri Sonam Lama, I/C NJP PS they failed to produce any valid document in support of possessing of the suspect to be Brown Sugar which they were carrying. After weighing, it was found that the plastic packet containing 94.76 grams suspected to be Brown Sugar. Accordingly, I seized the plastic packet containing 94.76 gram suspected to be Brown Sugar, and said Scooty and two keypad mobile phone from the joint procession of the above noted accused person. Then I sealed the plastic packet containing 94.76 gram suspected to brown sugar in an envelope, labeled the same and marked as Exhibit-'A'. the whole process of seizure and label is made in presence of I/C NJP PS Shri sonam lama and other two witness and dully acknowledge by the accused person. The whole process of seizure was made in between 23:40 hrs to 23:59 hrs under proper video graphy.


From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons named) Md. Rashil @ Racel (23/M), S/o- Amirul Hoque of Kalangini, PS- New Jalpaiguri, Dist. Jalpaiguri, 2) Abbas Ali (21/M) S/o Md. Bachhu of Fulbari Amaidighi, PS- New Jalpaiguri, Dist. Jalpaiguri (Not identified are involved in procuring and selling of Brown Sugar illegally and contravening the norms of NDPS Act was established. Then, I arrested the above noted accused persons after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the arrested
