breaking of property. at Sitala Bhawan; Pradhan Nagar ward. 2.

Dear Sir / Maam,

I am writing in a state of distress & fear for the safety of my family. Our cousin Mrs. Denika Chettri had constructed a boundary wall within her property because our ex-tenants Mrs. Bina Singh & Mr. Anirash Mishra were illegally occupying & trespassing our common area. The freshly constructed brick wall had not even set properly, but around 8:15am, today, we saw two female staff & two male staff (one name is Bimal) in their 'divya panchkarna' uniform breaking the wall with their own hands. Mrs. Denika Chettri had asked us to supervise the work, hence we went down to address the issue. Mr. Anirash hid the staffs immediately and started harassing me & my pregnant sister. Also he physically assaulted my 75 year old father and verbally abused our 70+ year old mothers. Sir, my elderly parents live alone and during summer I stay alone in the house (top floor).
