With due respect I (Rohan Tamang), Sp- Balram Tamang resident of Gandhinagar, Ward No. 43, P.S. Bhakti Nagar, Siliguri would like to address your attention towards an incident that has occurred today evening i.e. 11/02/21, time: 8:30pm. The incident took place in P.C. Mittal Bus stand in the premises of Pyasa F.I. offshop, near a high tension tower. The reason for this complaint letter is that, I (Rohan Tamang) along with my sister Nikita Lama were in the area of P.C. Mittal Bus stand for withdrawal of money from ATM. After withdrawing money from the ATM, we both were returning home but when we were crossing the Pyasa F.I. off shop premises, suddenly several drunkards started teasing my sister (Nikita Lama) and its retaliation, I spoke further with those 6-8 drunkards (who actually consumed alcohol from the same Pyasa F.I. off shop) but gradually they started abusing us and in time they started hitting me from behind. In this incident I am badly injured as I was beaten by 8 drunkards from best of my knowledge. After beating me they all ran away in their motor-cycles. Relating to this incident, some CCTV footages were also provided by the owner of the liquor shop. This heinous crime had a deep impact on our society and people (villagers) of our area are afraid of walking from that lane mostly at night. I humbly request you to take strict action against this violence, and I also request you to catch the drunkard's mob as soon as possible.
