Siliguri, Distt-Darjeeling do hereby inform you that on Dt. 13.02.2021 at about 07.00 pm, the following person namely, Md. Raj S/o Late Md. Gulzar, of Hemanta Basu colony, Ward No. 04 SMC P.O-Siliguri P.S. Siliguri, Distt-Darjeeling, came in front of my home at Maharaj colony, and started abusing my relative namely, Smt. Arati Saha (23) w/o Sri Bijay Saha, resident of Mulleguri, near Durga Mandir, Ward No. 45 SMC, P.O & P.S. Pradhan Nagar, Distt-Darjeeling, and when she protested, & my daughter namely, Miss Punam Saha (19) D/o Sri Suresh Saha of Maharaj Colony Near Kachra Maath, Ward No. 4 SMC, P.S. Siliguri, also protested, the said person, Md. Raj, beaten brutally with fist & blows and injured my daughter, Punam Saha, grievously. My said relative, Arati Saha noted above immediately took her to the Siliguri Distt. Hospital, and my said daughter, Punam Saha treated there. Md. Raj also torn off the clothes of Arati Saha and abused her.

Sir, the above noted alleged person is very desperate & dangerous in nature, and he has threatened us for dire consequences.
