This is to inform you that, today i.e. 11.02.2021 from midnight to early morning no power were reported from various locations of E.V. Pally and Haiderpara under Hakimpara CCC, WBSEDCL. Our mobile van enquired and restored all the 48 nos distribution transformers. Upon enquiry it was found that, isolators of all the distribution transformers were down by some unknown miscreants which was creating a disruption of power supply to the neighboring consumers for near about 8 hours, hence vast locality of E.V.Pally and Haiderpara area was gone under no power situation resulting huge consumer grievances.
