Raj (27) s/o Late Md. Gulzar, of above noted address, reached at Maharaj Colony, at that time, the following persons namely (1) Smt. Pulcani Saha w/o Sri Suresh Saha (2) Sunam Saha w/o Sri Suresh Saha, (3) Sulo Khatun w/o Md. Hakim (4) Dhinda Saha s/o Not known (5) Rabi Saha s/o Sri Suresh Saha, all are of Maharaj Colony, Near Kachra Maath, Ward No. 04 SMC, P.O & P.S-Siliguri Distt-Dajeeing, started abusing my said husband in filthy language and when I protested they called (6) Smt. Anali Saha (23) w/o Sri Bijoy Saha resident of Malloguni, Near Durga Mandir, Ward No-45 SMC, P.O & P.S. Pradhan Nagar, Distt-Dajeeing (7) Kali Saha w/o Sri Suresh Saha, (8) Smt. Sumita Saha w/o Sri Bijoy Saha, all are of Maharaj Colony, Near Kachra Maath, Ward No. 4 SMC, P.O & P.S-Siliguri, Distt-Dajeeing, and they all started beating my said husband brutally and injured my husband, and he received severe head injury and treated at Siliguri Distt. Hospital.

Sir, the above noted 08 (eight) alleged persons are very desperate & dangerous in nature and they have threatened me my said husband and my mother-in-law, namely, Shama Begum w/o Late Md. Gulzar of Hemanta Buser Colony Near Kachra Maath, Ward No. 04 SMC, P.O-Siliguri, Distt-Dajeeing, for dire consequences. So, please take necessary action against the above named alleged persons.
