Sir,

In producing herewith (05) five arrested accused persons namely (1) Bijay Sahani-26yrs s/o Debendar Sahani of Maharaja Colony, Near Vivekananda School, Ward No-IV, SMC PS Siliguri Dist Darjeeling (2) Sunny Paswan-22yrs s/o Raju Paswan of Bagrakote, Jyotinagar colony, ward no-20, PS Siliguri Dist Darjeeling (3) Ratnesh Paswan-21yrs s/o Badlu Paswan of Bagrakote, Jyotinagar colony, ward no-20, PS Siliguri Dist Darjeeling (4) Rakesh Ghosh-18yrs s/o Lt Gopal Ghosh of Tikiapara, Matangini colony, PS Siliguri Dist Darjeeling and (5) Karan Mahato-21yrs s/o Anil Mahato of Tikiapara, Matangini colony, PS Siliguri Dist Darjeeling arrested on 14.02.21 u/s- 41 Cr.P.C along with following seized articles viz:

1. One country made single shooter revolver fitted with trigger, which barrel in length approx -7 inch and butt in length approx 3" (Made of iron with wooden butt) loaded with one round 8 MM live cartridge from the possession of Bijay Sahani which was kept on his left Waist.
2. One iron made Dagger (Sharp cutting weapon) measuring about 10 inch (approx) including butt from the possession of accused Karan Mahato which was kept on his right waist.
3. One iron Crowbar measuring 38 inch (approx) from the possession of accused Sunny Paswan which was kept on his right hand.
4. Two bottles of Kingfisher strong Premium Beer from the PO.

I, SI- Srimanta Chatterjee of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 13.02.21 at 23.05 hrs received a sources information that 7/8 youths have assembled at Adarshanagar, near GOVT Saw Mill, Ward no-IV under Siliguri PS for making preparation to commit dacoity in a house of Khalpara under Siliguri PS area. The fact was diarized in G.D vide Khalpara TOP GDE No- 537 Dated 13.02.21 subsequently after sharing the information with my superiors and as per their direction, at 23.15 hrs I along with SI Sushanta Das, ASI Uttam Dhar, ASI Zinnat Ali, ASI Niranjan Sarkar, Const/239 Badal Barman, Const/390 Sujit Paul and CV/874 Pankaj Mondal all of Khalpara TOP along with kits left for the place to work out the information. This refers to Khalpara TOP G.D.E No. 538 dated 13.02.21 and Khalpara TOP MCC No-172/21 dated 13.02.21. We reached Adarshanagar, near Govt Saw Mill at 23.30 hrs and as per my information night van officer (K-27) SI Upendra Nath Roy with force also reached near Adarshanagar subsequently cordoned off the suspected persons as shown by the

source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 05 (Five) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Khalpara area.

I thereafter, seized the above noted Arms and other articles under proper seizure list and labeled duly signed by the witnesses and acknowledged by the accused persons. (The whole seizure was made on 14.02.21 in between 00.05 hrs to 01.05 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit dacoity in a house at Khalpara under Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Bijay Sahani-26yrs s/o Debendar Sahani of Maharaja Colony, Near Vivekananda School, Ward No-IV, SMC PS Siliguri Dist Darjeeling (2) Sunny Paswan-22yrs s/o Raju Paswan of Bagrakote, Jyotinagar colony, ward no-20, PS Siliguri Dist Darjeeling (3) Ratnesh Paswan-21yrs s/o Badlu Paswan of Bagrakote, Jyotinagar colony, ward no-20, PS Siliguri Dist Darjeeling (4) Rakesh Ghosh-18yrs s/o Lt Gopal Ghosh of Tikiapara, Matangini colony, PS Siliguri Dist Darjeeling and (5) Karan Mahato-21yrs s/o Anil Mahato of Tikiapara, Matangini colony, PS Siliguri Dist Darjeeling and others also arrange for its investigation.
