That today dated 12/02/21 of approx. 10 AM people residing nearby informed me about the cloth lying outside the shop. After which I opened the gate of the shop and found that miscreants have broken the roof ceiling and entered the shop, and flew away with ladies wearing (clothes / dress) of approx Rs. 38500 (Thirty eight thousand five hundred rupees only). It had 25 set of Kurtis, Pants and dupattas.
