Sir,

In producing here with the accused person namely- Fulen Sahani (55) yrs. S/O-Late Parmeswar Sahani of Santoshi Nagar, W no- 05, Near Ram Janki Mandir, P.S-Siliguri, Dist. Darjeeling, along with seized (i) 12 (Twelve) bottles of Himalaya Gold 60 up Country spirit containing 600 ML in each bottle mentioning M.R.P of Rs- 100/- in each bottle i.e. total amount Rs- 1200/- (One thousand and five hundred) in which 01 (one) bottle taken as sample and marked as Exhibit- "A-1".

I beg to report that today i.e. on 15-02-21 while performing special raid against illegal alcohol, at 20:55 hrs I received a source information that one person namely- Fulen Sahani (55) S/O-Late Parmeswar Sahani of Santoshi Nagar, W no- 05, Near Ram Janki Mandir, P.S-Siliguri, Dist. Darjeeling is selling huge alcohol in the house of the accused person at Alu Patty, near Rail Ward No-6, P.S-Siliguri, Dist. Darjeeling. Under Khalpara TOP without any valid license documents in higher price than the actual value for his illegal gain. Accordingly I informed the I/C, Siliguri P.S over telephone who directed and instructed me to verify the veracity of the information. Accordingly, myself along with force left for Alu Patty, Siliguri to verify the veracity of the information vide Khalpara TOP GDE No - 613/21 Dated: 15-02-21. After reaching Alu Patty, Siliguri, Darjeeling at 21:15 hrs and as shown by the source I found the above noted person is selling liquor secretly to different persons and seeing the Police party the above noted person try to run away but we managed to intercept him. On being asked he disclosed his identity as mentioned above. During search, I could recover the above noted alcohol kept in the shop of the accused person in a gunny bag. During interrogation he admitted that he is selling alcohol for his wrongful gain. On demand he failed to produce any valid license or documents in support of such business. During local enquiry it has been confirmed that the above noted person is selling alcohol illegally since. Accordingly, I seized the above noted recovered I.D. liquors under proper seizure list duly prepared, sealed and labeled in presence of witnesses and took their signature in the seizure list and label. Also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest observing all the formalities of arrest. The entire search and seizure process completed in between 21:20 hrs to 21:40 hrs on 15-02-21.

Under the above noted law may kindly be started against the above noted arrested accused person namely fact and circumstances, I therefore, pray that a specific case under proper section be registered against Fulen Sahani (55) yrs. S/O-Late Parmeswar Sahani of Santoshi Nagar, W no- 05, Near Ram Janki Mandir, P.S-Siliguri, Dist. Darjeeling for the possessing and selling alcohol illegally and arrange for its investigation.
