With due respect and producing herewith the arrested accused person namely Muneswar Gope @ Manua (39 yrs) S/O Late Kirshna Gope of Tinbatti Colony near GRID Ground, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure :-

1. 19 (Nineteen) numbers of paper made cartoon, each cartoon containing 48 bottles of "Imperial Blue" Superior grain Whisky i,e total 912 bottles "Imperial Blue" Superior grain Whisky containing 180 Ml in each bottle.
2. 14 (Fourteen) numbers of paper made cartoon, each cartoon containing 12 bottles of "Imperial Blue" Superior grain Whisky i,e total 168 bottles "Imperial Blue" Superior grain Whisky containing 750 Ml in each bottle.
3. 14 (Fourteen) numbers of paper made cartoon, each cartoon containing 24 bottles of "Officer Choice Blue" Pure grain Whisky i,e total 336 bottles "Officer Choice Blue" Pure grain Whisky containing 375 Ml in each bottle.
4. 9 (Nine) numbers of paper made cartoon, each cartoon containing 48 bottles of "Mc Dowell's No1 LUXURY Premium Whisky i,e total 432 bottles "Mc Dowell's No1 LUXURY Premium Whisky containing 180 Ml in each bottle.
5. 3 (Three) numbers of paper made cartoon, each cartoon containing 24 bottles of "Mc Dowell's No1 LUXURY Premium Whisky i,e total 72 bottles Mc Dowell's No1 LUXURY Premium Whisky containing 375 Ml in each bottle.
6. 7 (Seven) numbers of paper made cartoon, each cartoon containing 12 bottles of "Mc Dowell's No1 LUXURY Premium Whisky i,e total 84 bottles Mc Dowell's No1 LUXURY Premium Whisky containing 750 Ml in each bottle.

I, ASI Tarun Kanti Ghosh of NJP PS, Siliguri Police Commissionerate beg to state that on 16.02.2021 at 20.05 hrs I received a source information that one Muneswar Gope @ Manua of Tinbatti Colony near GRID Ground, PS- NJP, Dist.- Jalpaiguri stored a huge quantity of "I/D Liquor" at his resident at Tinbatti Colony with a view to send the same to Bihar for his wrongful gain. Accordingly, the matter was diarised vide NJP PS GDE No 816 dated 16.02.2021 and informed the fact to the O/C, NJP PS and as per his kind direction myself along with ASI Khagen Barman VP/13 Jamirul Islam CV/306 Biswajit Roy CV/123 Ratul Bhattacharjee all of NJP PS left for Tinbatti near GRID Ground to work out the information in hand. At about 20.25 hrs being shown by the source myself along with above noted officer and forces arrived at the house of the accused Muneswar Gope @ Manua and seeing the police the said accused try to flee away but we the police party managed to apprehended him and during searched and found a good number of Paper made cartoon containing I.D liquor in his residence. During interrogation the above noted accused disclosed his name and address as noted above and also disclosed that he had stored the said bottles of liquor for its sale to Bihar. On demand he failed to produce any valid documents in respect of the above noted I.D liquor kept in his residence. , I invite to the local people to help me for seizure of liquor bottles but no one came forward to help me. Hence I seized the above noted I.D liquor under proper seizure list u/s 102 Cr.P.C in presence of witnesses and arrested the accused person namely Muneswar Gope @ Manua (39 yrs) S/O Late Kirshna Gope of Tinbatti Colony near GRID Ground, PS- NJP, Dist.- Jalpaiguri under proper Memo of arrest and observing all the formalities of arrest. All the search and seizure is made in between 20.45 hrs and 22.55 hrs. On 16.02.2021.

Hence, it is evident that the accused person namely Muneswar Gope @ Manua (39 yrs) S/O Late Kirshna Gope of Tinbatti Colony near GRID Ground, PS- NJP, Dist.- Jalpaiguri is involved in selling of I.D. liquor without any valid license for his wrongful gain.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of law may kindly be started against the accused person namely Muneswar Gope @ Manua (39 yrs) S/O Late Kirshna Gope of Tinbatti Colony near GRID Ground, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
