1. **Md. Aibul Haque Chowdhury**, S/o Late Israil Haque Chowdhury, Resident of Mahanandapara, P.O. Siliguri, P.S. Siliguri, in the District of Darjeeling would like to lodge a written complaint stating as follows:

1. That my father namely Late Israil Haque Choudhury S/o Late Late Ismail Haque Chowdhury died on 25.04.1990 who was the last Mutawalli of "Hazi Enayetulla And Bibi Premeswari Wakfs State" vide E.C No.5454.
2. That said Wakfs State is the owner of huge quantum of landed property appertaining to and forming part of RS Plot No. 203, 225, 228, 236, 239, 241, 242, 243, 244, 245, 240, 222, 223, 221 in 14 plots recorded in RS Khatian No. 2, Mouza:- Ujanu, J.L No.108, Pargana :- Patharghata, Police station :- Matigara, in the district of Darjeeling.
3. That since last few days local land grabbers of the area namely **Rajesh Toppo, Bisu Sarkar, Sintu Debnath, Gopal Giri** resident of unknown are continuously trying to take the illegal possession of the said landed property of the said Wakfs State.
4. That on 10.02.2021 said miscreants once again tried to take the illegal possession of said landed property by construction puecca structure and on our resistance said miscreants flew away from the spot with the threatening and warning that they will anyhow will take the illegal possession of the said landed property of the said Waki's State.
5. That the said miscreant are local land grabbers and are very dangerous in nature and for achieving their malafide and sinister goals can go to any extent and won't even hesitate to shed blood.



Therefore, in the prevailing circumstances you are humbly requested you to take necessary, immediate and protective steps.
