

Dear Sir,

With due respect, Sri Bipul Roy, S/o. Sri Bimal Roy, resident of VII: Chhotdhukuriajote, P.o. New Champita, P.s. Matigara, Dt. Darjeeling would like to inform you that one Harikishore Roy is the sole absolute owner in possession of PWD land measuring about 2.93 decimal (2 Katha 5.77 Chatak) in plot 656(L.R) in Mouza Guria, J.L No. 56, P.S. Matigara, Dt. Darjeeling and vest land measuring 3.90 decimal (2 Katha 5.77 Chatak). After his demise abovesaid Harikishore Roy left 5(five) legal heirs namely (1) Smt. Rita Sen Roy (wife), (2) Smt. Monalisa Roy (daughter), (3) Smt. Aloka Roy (married daughter), (4) Smt. Kabita Roy (married daughter), (5) Smt. Ratna Roy (daughter) as his only legal heirs and successors according to Hindu law of inheritance. The abovesaid Rita Sen Roy and Smt. Monalisa Roy acquired abovesaid PWD land measuring 2.93 (1 Katha 12.44 Chatak) together with one 1/2 finished 1/2 ruff made house consisting two rooms jointly out of their family settlement. The abovesaid Rita Sen Roy and Smt. Monalisa Roy jointly approached their desirousness to sell their acquiring landed property with house to me at and for the price of Rs. 16,00,000/- (Rupees sixteen lac) only by issuing one proposal letter dated 08.01.21. In response to their letter I accepted their proposal for sale in respect of abovesaid landed property at and for the price of Rs. 16,00,000/- (Rupees sixteen lac) only and I have paid total sum of Rs. 16,00,000/- (Rupees sixteen lac) only both of them on 15.01.2021 which they have acknowledged the same by signed one money receipt on that day. Soon after the paying total consideration money they have handed over the key of one room to me and in another room they are starting to live as tenant by executing one tenancy agreement with me where they have agreed to pay a sum of Rs. 15,00/- (One thousand five hundred) only and they have paid a sum of Rs. 7,500/- (Rupees seven thousand five hundred) only as security deposit.
