Babita Paswan (2) Sarita Paswan, both daughters of Sri Raju Paswan (3) Monika Paswan (4) Naina Paswan, both daughters of Sri Sudhir Paswan (5) Chhotu Paswan s/o Raju Paswan (6) Smt. Sanju Paswan w/o Sri Sudhir Paswan, all are resident of Santoshi Nagar, Near Radha Krishna Mandir, ward No 5 SMC, P.O.-Siliguri Bazar, P.S.-Siliguri, Distt.-Darjeeling, and started abusing me in filthy languages and when my daughters namely (1) Anjali Das and (2) Karishma Das, protested they started beating us brutally with fist and blows and injured me grievously. I immediately shifted to Siliguri Distt. Hospital, and I received the treatment there.

Sir, the above named alleged persons are very desperate & dangerous in nature and they have threatened us for dire consequences.

Sanju Paswan w/o Sri Sudhir Paswan, all are of near Radha Krishna Mandir, Santoshi Nagar, ward No 5 SMC, P.O.-Siliguri Bazar, P.S.-Siliguri, Distt.-Darjeeling
