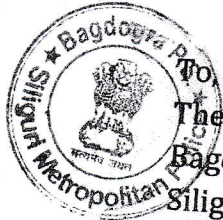

Sir,

With due respect, I SI Bhabatosh Sarkar of Bagdogra P.S, SPC hereby lodge a complaint against namely Ganesh Pradhan S/o Late Sidhhi Mon Pradhan of Dara Gaon P.O & P.S Bagdogra, Dist. Darjeeling to the facts of the case in brief is that on 15/02/2021 at about 00:20 hrs in course of my GDE duty at Bagdogra Police Station the above named person forcefully entered into the police station and lubricious and demand for released his son namely Manoj Pradhan and other arrested accused persons those are arrested in connection with Bagdogra PS Case no.60/2021 dated 15.02.2021 u/s 448/323/354/427/379/506/34 of IPC. Accordingly when I tried to understood the matter and told him to control himself then he became very furious and used criminal force to discharge my lawful duty. When the other Police Persons tried to conciliated him, then he started pushed out them and catches the collar and socked the police personnel.

Under the above facts and circumstances, I request you that a specific case against the aforementioned person may kindly started against him with suitable sections of law.
