This is to inform you that on 17 Feb 2021 at 0200 hrs to 0230 hrs one incidence of theft occurred at my above mentioned house. About 3-4 persons forcibly entered into the room by breaking window boxes and cub boards from where they have taken out our ₹ 50,000/- (Rupees Fifty thousand) one set of gold Jewellery (Ear ring) and 02 (two) mobile set bearing Sim card no. 9476301560 & 8617592328. On hearing loud sound my wife came forward to approach those when they tried to attack her with weapons. Hearing our hue & cry neighbours started coming towards my house, at that time the miscreants/culprits were fled away by threatening us not to challenge them.

We reported immediately to the police by dialing 100 at around 0330 hrs. The police personnel reached the spot within short time to investigate the matter. We reported all the happenings to the police personnel. This is for your kind information and necessary action.
