I Hasina Khatun, W/O Md. Anwarul Sheikh, R/O Adarsh Nagar Colony, Ward No. 4 of S.M.C. Near Government Saw Mill, Siliguri, P.S. Khalpara, Dist: Darjeeling, Pin Code: 734005, begs to report you the following facts:

1. That Md. Anwarul Sheikh, S/O Md. Usman of Circus Lane, Mauccha Patti, P.O & P.S. Nagrakata, Dist:- Jalpaiguri is my legally married husband. Our marriage was solemnized on 23<sup>rd</sup> May, 2012, according to Muslim law, rites and customs and we have our girl child out of our said wedlock relation.

That my father gave cash Rs 1 lakh, Hero Karizma Motor Cycle, gold ornaments weighing 42.401gm bharies, silver ornaments weighing 544.370 bharies, godrej, fridge, wooden khat, T.V., home theater, expensive utensils, bedding, clothing and other house hold articles to my husband as per his and his family members demand.
3. That few months after my marriage, my mother in law namely Mairun Khatun, W/O- Md. Usman, father in law namely Md. Usman, my one younger sister in law namely Glupsa Khatoon, D/o- Md. Usman, my brother in law namely Anwar Sheik(Pappu), S/O- Md. Usman and his wife RC Jahan Khatoon and Md Ansarul (Phul) S/O- Md. Usman and his wife Momina Khatoon and Uncle namely Md. Wazir Ansari all are of Circus Lane, Mauccha Patti, P.O & P.S. Nagrakata, Dist:- Jalpaiguri started to torture me both physically and mentally for bringing cash Rs.5 lakh for starting business of my husband and brother in law, from my fathers house but I could not fulfill their such demand due to my father's poverty. As such their torture upon me increased rapidly day by day. They did not use to provide me proper food and clothing and made me
