In producing herewith Two (02) arrested accused persons namely (1) Jayanta Roy (26) S/O Sri Satyendra Roy of Bholanath Para PO Ghugumali PS Bhaktinager Dist Jalpaiguri and (2) Niren Das (19) S/O Sri Kiran Das of Khai Kahi bazaar PO Sevok Road PS Bhaktinager Dist Jalpaiguri after preparing proper seizure list and arrest memo along with the following Seized articles- (1) One KHLUSKAR water pump KHLUSKAR CRYSTAL size-25 x 25MM, 7.5 W/1.10 HP, head 6.5-20M Ssn. G20PPH023864 made by KHLUSKAR Brothers Ltd And (2) One CRU pump, model no. DORADIM, 21, 24W, 50Hz, 52, CSR, CLR, size 25x25 MM, 1.0 HP, Ssn. 13719624115 made by CRU pump Pvt Ltd. Seized from the joint possession of above noted accused persons.

I ASI Ashis Karmakar of Ashighar OP under Bhaktinagar PS, SPC beg to lodge a complaint against above noted accused persons that on 17.02.2021 at 19.45 Hrs received a source information that two persons is going towards Khai Kahi bazaar from Bholanath Para side with two numbers of Water pump stolen from unknown place. Noted the fact in GD vide Ashighar O.P GDE no. 405 DT-17.01.2021. On receiving the information as per the order of O.C Ashighar OP, I along with available officer and forces immediately rushed to the spot vide Ashighar OP GDE no. 406 Dt. 17.02.2021 I along with the officers & force reached at Khai Kahi Bazaar area under P.S- Bhaktinagar and as per indicated by my source we surrounded the above noted persons at Khai Kahi bazaar. Seeing the Police party they tried to escape but after hot chase we apprehended them and found two numbers of water Pump Machine in their possession. On being asked they disclosed their name and address as noted above. On demand they failed to produce any documents in support of above water Pumps. Further asking they could not give any satisfactory answer about the water pumps in their possession moreover on asking they made some contradictory statement which is a reason to believe that they procured the above water Pumps by fraudulent means or stolen it from somewhere. During interrogation they disclosed that they had stolen the above water Pumps from Bholanath Para area and brought at Khai khai bazaar for selling it clandestinely. Accordingly I seized two numbers of water pumps from the possession of the above accused persons under proper seizure list U/S 102 Cr.P.C and arrested them U/S 41 Crpc after supplying proper Memo of arrest. Search, seizure and arrest were made in between 20.30 hrs to 20.50 hrs.

Under the above circumstances, I pray to your end for starting a case against the arrested accused persons namely (1) Jayanta Roy (26) S/O Sri Satyendra Roy of Bholanath Para PO Ghugumali PS Bhaktinager Dist Jalpaiguri and (2) Niren Das (19) S/O Sri Kiran Das of Khai Kahi bazaar PO Sevok Road PS Bhaktinager Dist Jalpaiguri under proper section of law and arrange for its investigation.
