Under the above circumstances I would like to request you to investigate the matter and do needful for the ends of justice.

Dear Sir,

With due respect I the undersigned would like to inform you that, on 16.02.2021 at about 10 p.m. at night, (1) Bipul Baidya, S/o. Dulal Baidya, (2) Bishal Baidya, S/o. Bipul Baidya, (3) Bappa Basak, S/o. Bapi Basak all are resident of Hatiaqdanga, P.O Sahudangi Hat, P.S Bhaktinagar, Dist. Jalpaiguri, alongwith 15 others unknown persons came to my house and called my husband from outside of my residence and thereafter my husband came out from the residence and after reaching in front of the entrance of my house, the above named persons have started to assault my husband by fist and blow and kick in the different part of the body of my husband and due to the said assault my husband fell down on the earth and thereafter they all together have started to assault my husband on rotation brutally and they abused filthy languages indicating my husband and told loudly that they would kill my husband and in the meantime Bipul Baidya has throttled the neck of my husband and for that my husband sustained a severe injury in his neck and also he sustained blood injury from the nail of the said Bipul Baidya and due to such brutal assault my husband sustained severe blood injury on his head, lips and also different part of his body. In the meantime getting the said loud noise I alongwith my mother in law came out from my house and saw that the above named persons have been assaulting my husband and seeing the said act, I tried to resist them and rescue my husband from their grip but the above named persons have pushed me forcibly and they also molested the private part of my chest and they also tried to put off my saree and for that I was exposed openly and thus they have intentionally outraged my modesty.

I would like to further inform you that, the local people have somehow rescued my husband from them and ultimately they left the said place and before leaving they threatened openly that they will diffidently kill my husband next time. However I took my husband inside of the house and due to fear of such threatening and ill behave with me I was quite astonished and for that I could not lodge the complaint at late night to you. On the next day I brought my husband to the Siliguri Sadar Hospital due to his
