3. That in my above land, myself and my daughter Kumari Purnima Gupta, staying in a Kacca Cottage built with Bambo and Timb. We have applied for Electricity Connection in my Land/Cottage. As, we both are living in darkness.

They threatened the Staffs of WBS&DCL Pradhan Nagar, that they will do physical Assaults with them if they do not abide-by their orders. With that, Staffs of WBS&DCL, affraid off flew away from the place.
