Sir,

In producing herewith one arrested accused person namely Bikram Saibo (30), S/O – Lt Anik Saibo of Debidanga, Sishabari, P.S. Pradhan nagar, Dist- Darjeeling along with seized article viz; i) One black and Steel (In butt portion) & iron made Pistol, having barrel length about 16cm (Approx) and butt length 10cm(Approx), ii) One Magazine case length 10cm(approx) & iii) 03 round ammunitions marked as KF7.65, which was loaded in the above said pistol.

I beg to report that I ASI Dharendra Nath Mandal of Pradhannagar Police Station, SPC do hereby lodge this complainant against the above noted accused person to the effect that on 14.02.2021 around 13:20 hrs received a secret information from my reliable source that one person (noted above) is roaming suspiciously at Mech busty, Sishudangi area, under Pradhannagar Ps and threatening local people showing pistol. Immediately the matter was informed to you vide Pradhan Nagar Ps GDE NO. 741 DTD. 14.02.21 and under your kind direction myself accompanied with SI Samik Paul, CV 131 Ranjan Sharma, CV 128 Ajay Kr. Sahani of Pradhannagar P.S proceeded to work out the information. And at about 13:55 hrs we arrived at the said place and again contacted with my source and on being indicated and identified by him, I along with my police party apprehended the above noted person at Mech busty sishudangi under Pradhannagar Ps. We gave our identity and also disclosed the information in hand in presence local witnesses. On asking he gave his identity as noted above. On being searched the person recovered one black and Steel & iron made Pistol, having length about 16cm (Approx) and butt length 10cm (Approx) loaded with 03 round 7.65mm ammunition marked as KF7.65, which was kept in the back side of his waist. On interrogation the accused person made Incoherent statement regarding possession of the Pistol and failed to produce any valid license for possessing the said arms. Accordingly, I seized the pistol loaded with 03 round ammunition under proper seizure list. (Seizure was made in between 14:10 hrs and 14.35 hrs) duly signed by the accused person as well as witnesses in the seizure list and arrested the accused person for violation of the provisions of Arms Act.

On the above circumstances, I pray that a specific case under proper section of law may kindly be started against accused person namely Bikram Saibo (30), S/O – Lt Anik Saibo of Debidanga, Sishabari, P.S. Pradhan nagar, Dist- Darjeeling and arrange for its investigation.
