hit my son on his head brutally with axes,

even the owner with his son's was slang
languages and also hit me severely. They did it
even thought that I am a woman.

Therefore I kindly requested you to kindly
look forward to this incident, because my son is
seriously injured and has been admitted in the
Solegnai District Hospital. So that the culprits
should be punished, with the favour of your
appreciation with ledging as F.I.R.
