



Dear Madam,

With due respect I, SMT. PHULMATI ROY, W/O Sri Khirad Roy resident of Pradhan More, Ektiasal, Ward. No. 40, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri, would like to lodge this written complaint to the effect that toady at late night at about 12:15 hrs two persons namely Sri Chanchal Roy, S/o unknown and Smt. Lakhi Roy, W/o Sri Chanchal Roy, residing at Parasmani Road, Haider Para, P.S. Bhaktinagar, District- Jalpaiguri along with some 5-6 persons were stopped before our house and parked one two wheeler bike before our house and they were doing some obscene acts and using filthy languages outside our house. I run a grocery shop at my same house and at that point of time my younger son namely Jayanta Roy was present at the shop and he was closing the same shop. That on the wrongful acts of the above named persons he raised his voice and request them to leave, but the above named persons instead of leaving the place they became furious and started to use filthy language upon my younger son and after watching this my elder son namely Bijay Roy came to the spot and tried to silent the above mentioned persons but they started to assault my both sons and me by fists and blows and stones and during that time said Chanchal Roy touched my private parts and torn my wearing apparels by using criminal force and outraged my modesty by using filthy languages and snatched my golden chain and the 5-6 unknown persons snatched the wallet of my elder son which was containing 3,500/- (Rupees Three Thousand Five Hundred) only and they tried to enter into my house but at the same time the neighbors came and rescued us from those wrongdoers seeing the said situation, left the spot
