I, **Smt. Sampa Roy**, Wife of Sri Ajit Roy, resident of Baneshwar More, P.O. Sevoke, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against Sahadeb Roy, Son of Paresb Roy, Ajay Roy, Son of Haresh Roy, and Smt. Pushpa Roy, Wife of Ajay Roy, all are resident of Baneshwar More, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effect that on 19-02-2021 at about 2:00 pm, said Sahadeb Roy, Ajay Roy and Smt. Pushpa Roy physically assaulted my husband with fists and blows, kicks and wooden log and they dashed the head of my husband against the pucca wall several times and due to their physical assault, my husband sustained grievous head, mouth and finger injuries and blood was oozing out of his mouth and finger and they also physically assaulted me by fists and blows and wooden log and catching hold of my hair dragged me and due to their assault, I sustained chest injury and on my person.

I along with my husband were rushed to the Siliguri District Hospital by my brother-in-law, Biswajit Roy for treatment and after seeing the condition of my husband, the concerned Doctor advice to have CT Scan of his head he is presently admitted at Siliguri Dist. Hospital, Siliguri and his condition is grave and serious as the blood has been still oozing out from his mouth.

So, therefore, I humbly request your goodself to take necessary legal action as per provision of law against the said Sahadeb Roy, Ajay Roy and Pushpa Roy at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
