Sub: Complaint for attack, physical assault and grievously hurting me by Ajay Biswas, Sanjay Biswas, Rajiv Rava, Jaga and others.

Dear Sir,

I, Bishnu Roy, S/o Sri Mantu Roy aged about 22 years resident of Vivekananda nagar, SMC Ward No. 42 P.O. Salugara, P.S. Bhaktinagar, District- Jalpaiguri, would like to inform you that I was at my residence on 16-02-2021 at around 8.30 p.m. when I was called by Ajay Biswas from outside my residence and when I came out of my house he called me little further to talk and I saw Sanjay Biswas, Rajiv Rava, Jaga and 3 others standing there. When I reached near them all of them together with Ajay Biswas at once attacked at me with belts, they also hit me with hand and legs without giving me any chance to escape. They also snatched a gold chain from my neck and took away money around Rs.1,500/- which was in my pocket. Upon my shouting and screaming some people gathered there and my father rushed to my rescue from inside of my house but tiii then the above miscreants ran away from the site. I then rushed to the Siliguri District Hospital and treated there and after such release I was advised total bed rest, Thus I would like to lodge the complaint today.

Further I would like to bring to your knowledge that the above known miscreant i.e. Ajay Biswas S/o unknown, Sanjay Biswas S/o unknown, Rajiv Rava S/o unknown, Jaga S/o unknown are the residents of Palpara, SMC Ward No. 42 P.O. Salugara, P.S. Bhaktinagar, District- Jalpaiguri, and have threatened to harm me physically, and kill me if I complain to the police and any legal action is taken against them.

Sir, in the above circumstances I am in due fear and trauma due to such severe attack on me in front of my residence and threat to my life. Thus I pray before you to take appropriate action to protect me and provide me liberty to live peacefully.
