I, Sri Sushil Mitruka, Son of Sri Neem Chand Mitruka, presently Residing at Uttarayon Township. Matigara, P.S. Matigara, District- Darjeeling, Pin - 734010 do hereby lodge this complaint against Sri Kajal Sarkar, Son of Sri Kamal Sarkar, Resident of Dakghar Sarani, P.O. Bhaktinagar, P.S. Bhaktinagar, Siliguri- 734007 to the effect as follows:

- 1. That I have sent a complaint through email on 02.09.2020 against one Kajal Sarkar and others for committing forgery/cheating/ falsification of signature and seal/using the forged document as genuine one before the Ld. District Judge at Darjeeling.
- 2. The Copy of the said complaint was also submitted upon the Commissioner of Police.d Siliguri on the same day. Thereafter my original written complaint along with forwarding letter was has been sent through registered post on 03.09.2020 with a request to register my complaint as F.I.R. under section 420/465/467/468/471/120B of the Indian Penal Code.
- 3. Be that as it may as there is no such progress again 1 am lodging this complaint with the following facts.
- 4. That I am the Designated Partner of Haldibari Tea Manufacturers LLP, having its registered office at G-208, Office Block, City Center, Uttarayon Township, P.O. and P.S. Matigara. District Darjeeling- 734010 along with my Daughter Smt. Ruby Mitruka, as its another Designated Partner.
- That I have filed an application under Section 9 of the Arbitration and Conciliation Act, 1996 before the Ld. District Judge at Darjeeling being Misc. (Arbitration) Case No. 04 of 2020 and have obtained an ad-interim order of injunction dated 24.07 2020 against Shri Kajal Sarkar which has been extended time to time by Ld Court and is still in force The Ld. District Judge at Darjeeling vide its order dated 24.12.2020 at Page 7 of the said judgment, observed that he has used the forged document by showing dishonest intention for his illegal gain. The copy of the said judgment is annexed herewith which is self explanatory

- That the final hearing of the case was concluded on 28.08.2020 at Siliguri Court Premises. Today i.e. on 02.09.2020, I have received a Copy of an Agreement dated 15.05.2020 that has been filed before the Ld. District Judge at Darjeeling in the said case on behalf of Shri Kajal Sarkar During the course of hearing the said Kajal Sarkar never referred to the said Agreement before the Ld. District Judge at Darjeeling and it was non-existent at any point of time nor has it been mentioned in their written statement filed before the Ld. Court. On perusing the said document I was shocked/ surprised as I have never entered into such agreement nor have I signed or executed any such agreement with Shri Kajal Sarkar or anyone else. I would to mention here that the seal and my signatures put in the said Agreement dated 15.05.2020 is forged by Sri Kajal Sarkar and is a manufactured, fabricated and sham document and does not have any existence in the eye of law.
- 7. On examining my signature in the said Agreement dated 15.05.2020 I state that my signatures have been forged by Kajal Sarkar to support his false claims regarding the contents of the said Agreement. The offence of Kajal Sarkar is clearly visible from the fact that my forged signatures appearing in each page of the said agreement are different from each other. however such false, fictitious, fabricated, manufactured and forged document does not bind me in any manner and also does not create any claim or right of Kajal Sarkar to my detriment.
- 8. That the said Kajal Sarkar has dishonestly and fraudulently made, prepared the seal of the LLP, drafted the agreement, put my forged signatures and used the said document as genuine by filing it before the Court of the Ld. District Judge at Darjeeling.
- 9. That Sri Ratan Kumar Bagchi (Notary) and one Sri D. Karmakar, Advocate are part of the conspiracy in preparing the said Agreement as they have authenticated, certified, attested and identified the signatories to the said Agreement. The witnesses namely Hala Dhan Barman and Susanta Bose are also part of the conspiracy as they have aided Kajal Sarkar in commission of the said offence.
- 10. That the said Kajal Sarkar has made false and misleading statements in the said agreement and has falsely stated that he has invested money to the tune of Rs. 4.40 crores in the Tea Business of the LLP and further false statements that I have given my free consent/ NOC to Sri Rajendra Bajoria, Director of Huldibari Industries and Plantations Company Limited to execute any kind of agreement or transfer in respect of Huldibari Tea Estate in favour of Sri Kajal Sarkar for his illegal gains.
- 11. It will be pertinent to mention here that the said Kajal Sarkar has threatened me of dire consequences and is trying to take over my business using force, unlawfully and in this regard several complaints have been made before Siliguri Police Station and also before the Commissioner of Police at Siliguri.
