Sir, all the above named persons are openly threatening us that at any opportunate moment they may commit rape upon us. They are very dangerous and desparate in nature, they may at any opportunate moment translate their threat into real operation.

Due to their such assault I received severe injury and I was treated at Siliguri S.D. Hospital and still then I was under medical supervision and for such reason I could not lodge my F.I.R. in due time which may kindly be condoned.

I, therefore, request you to kindly take necessary legal steps against the aforesaid culprits for commission of aforesaid offence by them upon us.

I, Pinky Roy, Wife of Rajen Pandit, resident of Gauranga Pally, South Ektiasal, Ward No- 40 of S.M.C. P.O. Haider Para, P.S. Bhakti Nagar, Dist. Jalpaiguri, beg to report you the following facts:-

- 1) That on 21.02.2021 at about 4 p.m. when I and my nanad namely Sabitri Pandit, 14 years old (minor) were standing in front of the main gate of our house at that time (1) Bhola Das Son of Ravi Das, (2) Ravi Das Son of not known to us, (3) Sima Das, D/O. Ravi Das, (4) Babita Das, wife of Bhola Das all of of Gauranga Pally, South Ektiasal, Ward No- 40 of S.M.C. P.O. Haider Para, P.S. Bhakti Nagar, Dist. Jalpaiguri, suddenly came infront of us and started abusing us in filthy and offensive languages, when we tried to resist them at that time all of them forcefully threw me on the ground and started beating me mercilessly, all the above named persons almost made me nacked by tearing my wearing apparel, seeing this my Nanad Sabitri Pandit tried to save me at that time Bhola Das and Ravi Das caught hold her and started out raging her modesty, they touched her private parts and molested her, seeing this we raised hue and cry and hearing our hue and cry para people gathered there and save us from their hands.
- 2) That after that on 22.02.2021 at about 1 a.m. said persons forcefully entered into our house and threatened us and when we resisted them they assaulted us again and threatened us that if we inform the aforesaid fact to anyone then they will commit rape upon us and no
