In producing herewith one arrested accused person namely Md Ali (21) S/O Md. Noor Mahammad of Tikiapara, Mazdoor Colony ,Ward no.28, PS- Siliguri, Dist- Darjeeling along with seized 30 (thirty) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal.

I, SI Hiru Kanti Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Md Ali (21) S/O Md. Noor Mahammad of Tikiapara, Mazdoor Colony , Ward no.28, PS- Siliguri, Dist- Darjeeling to the effect that on 21.02.21 at 19.05 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at Tikiapara Railway Gate under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Siliguti PS. As per his direction I along with ASI Subir Sarkar, ASI Siben Sarkar, C/971 Sanjay Roy, CV/145 Bijay Das and CV/622 Ramanath Barman left for Tikiapara Railway Gate under Siliguri PS vide Siliguri P.S GDE NO: 1227 to verify the veracity of the information. On reaching at 19.15 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot, but we managed to apprehend him and on interrogation, the above noted person disclosed his identity as noted above. On searching we found that 30 (thirty) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since last eight (08) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure was made in between 20.15 hrs to 20.45 hrs. On being asked he stated that he used to sale the same to locality without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him U/S-41 Cr.P.C after observing all sorts' of rules for selling the said country made sprit without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Md Ali (21) S/O Md. Noor Mahammad of Tikiapara, Mazdoor Colony ,Ward no.28, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigate.
