Dear Sir,

With due respect I the undersigned would like to inform you that my father Joyendra Nath Dey Chowdhury (since deceased) had given me the marriage with Sri Digendra Nath Kundu on 30/11/1993 and out of the said wedlock I had given birth of a female child on 26/03/1995. Since the year of 2012 there was some matrimonial dispute has been cropped up between me and my husband and I was thrown out by my husband from my matrimonial house and I was compelled to take the shelter of my father and I along with my daughter have started to reside with my father's residence at Ashram Para, Budhadeb Basu Road, Siliguri, P.O. & P.S. – Siliguri, Dist. Darjeeling on and from first part of the month of February, 2018. Due to such shifting and starting to reside with my father, my younger brother Sri Subhankar Dey Chowdhury, his wife Smt. Babita Dey Chowdhury @ Mou, my younger sister Smt. Rakhi Paul Chowdhury and her husband Sri Debabrata Paul Chowdhury @ Titu have started to misbehave with me and my daughter so that I along with my daughter would leave the place of my father and they also started to put pressure upon my father to shift somewhere else from the said residence.

During the life time of my father, he earned a lot and he acquired several valuable movable and immovable in the different places like Siliguri, Jalpaiguri, Chopra, Kolkata and he was a reputed business man.

Since the date of the matrimonial dispute which was commenced on and from the year 2011, I was subjected to mental and physical torture by my husband and at that time I used to stay at Kolkata and I was badly busy for looking after my minor daughter and also other litigations and proceedings out of said matrimonial offences and for that my father (since deceased) was very upset in respect of my future and social status as well

as the future of my minor daughter at that relevant time. Taking the said advantage of my busyness and such upset of my father due to the emotional attachment with me as I am the elder daughter and there was so love and affection towards me and my minor daughter by my father, my younger brother and sister and the husband of my sister had started to put pressure upon my father to sale the said valuable immovable properties so that my father may not give any property to me and my daughter and due to the protest as made by the first wife of my younger brother against such illegal act of my younger brother and sister and her husband, my younger brother had thrown out his first wife and subsequently in the year of 2012 my younger brother had entered into the second marriage but his second wife had also protested against such illegal act and my younger brother has also left her and their marriage was dissolved by a decree of divorce.

I could gather from my limited source and knowledge, since 2012 my younger brother, sister and her husband had compelled my deceased father to transfer the numerous number of valuable properties situated within the jurisdiction of Jalpaiguri District by virtue of the registered Deed of Sale being instrument no. 4722 dated 08/06/2012, 5257 dated 22/06/2012, 4070 dated 24/04/2013, 56 dated 16/12/2015, 713 dated 31/05/2017, 233 dated 23/02/2018, within the jurisdiction of Darjeeling being instrument no. 2042 dated 09/09/2019, within the jurisdiction of Chopra being instrument nos. 2318 dated 28/05/2014, 3176 dated 31/08/2016, 2715 dated 02/08/2018, 3615 dated 25/10/2019, 3614 dated 14/11/2019, 2905 dated 14/08/2019, 2904 dated 14/08/2019, 530 dated 30/01/2019, 529 dated 30/01/2019, 528 dated 30/01/2019, 527 dated 30/01/2019, 522 dated 30/01/2019, 35 dated 07/01/2020, 522 dated 30/01/2019. The total consideration from those transfer as stated above are more or less Rs. 30 Crores and I could believe apart from the above mentioned transfer, there are so many other transfer in respect of the valuable properties of my father and same had / has been done by my father due to the tremendous pressure and torture upon my father by my younger brother, sister and her husband my deceased father was compelled to transfer those valuable properties and after the said transfer

the entire consideration had been forcibly taken by my younger brother and my younger sister and her husband have also got some share from there as per their understanding.

I would like to further inform you that my younger brother has started to torture upon my father for transferring three number of valuable residential and commercial building in his name and due to such continuous in human torture my father was compelled to transfer his residential building situated at Ashram Para, Budhadeb Basu Road, P.O. & P.S. Siliguri, Dist. Darjeeling in favour of my younger brother by virtue of a registered Gift Deed and after the said transfer my younger brother has again started to put pressure upon my father to transfer the remaining two buildings and on refusal he started to assault my father on the various occasions and getting this information in the month of January, 2020 I have tried to come to my father but my younger brother and his wife, younger sister and her husband resisted me to enter into the house and I was compelled to return in Kolkata.

That my father had acquired a valuable landed property measuring about 6 kathas 4 chhataks situated at Ward No. 41 of S.M.C., beside Bottle Factory, Baikunthapally, P.O. – Sevoke Road, P.S. – Bhaktinagar, Dist. Jalpaiguri and it was the desire and dream of my father that he would open a school there for orphan children and he told me to run the said school but it was very unfortunate that my younger brother and his wife, younger sister and her husband forcibly compelled my father to transfer the said property against the valuable consideration on 07/01/2021 and took the said amount and kept the same in their custody and after the said forceful transfer through my father he was very much upset.

After the said transfer as stated aforesaid, my younger brother and his wife, younger sister and her husband have accelerated the quantum of torture upon my aged father to transfer his all remaining movable and immovable including the remaining two commercial building situated at Ashram Para (Centurian Garden and one four storied building situated opposite of Centurian Garden) in their name and on refusal on

29/01/2021 they assaulted my father and my younger brother with the assistance of his wife, sister and her husband throttled the neck of my father with an intention to kill him and for that my father suffered of a lot of pain and he also shouted loudly for saving his life from their grip but he failed to save his life and on that day at late night he was killed but my brother and his said associates killed my father with preplan and did not leave any mark very tact fully but the impression of the face of my father was last seen which is very clear that he died with severe pain as given by my younger brother and other associates and for avoiding the legal consequence they shifted my father at Neotia Getwel Nursing Home in the evening on 30/01/2021 just to obtain a medical certificate from there. On 02/02/2021 the nursing home authority declared that my father died on that day but practically my father was killed on 29/01/2021 at late night but the said information of death was suppressed by my said brother and the other associates and very tactfully they completed the funereal work and I was not allowed to enter into the house by them. Thereafter I tried to collect the information from the neighbors and other well wishers regarding the cause of the death of my father and delay of lodging of this complaint can not be condoned the heinous offence of my younger brother and his wife, younger sister and her husband.

Under the above circumstances I would like to request you to investigate the matter and do needful for the ends of justice.
