I, undersigned write to you to register a case against  
Kajal Das, son of Ranjan Das, temporarily residing at  
NTS More, Deshbandhupara, Siliguri, (Maa Tara Sweet Shop).

That, I got married to Kajal Das around three years  
ago in at his house. Due to his ill behaviour and verbal  
and physical abuse I left him for my own peace and  
started living with my parents. Presently, I am working  
as a househelp at a residence on the bylane of Vidya Sagar  
Pally, Siliguri. I have been living with my parents for two and a half  
years now. Today at around 7:30pm when I left the house  
where I work for my place of residence I found Kajal  
Das standing outside this house where I work. Upon seeing  
me he started abusing me and even tried to hit me. I  
somehow saved myself and dragged him to Khalpara T.O.P.

He has repeated such behaviour earlier as well.  
He used to threaten me and my family members. My  
family members and I along with nearby residents have  
tried several times to explain to him to not repeat such  
behaviour but to no avail.

After today's incident, I am very much worried  
about my safety and I am scared of Kajal Das. I beg  
you to take appropriate action against him.

The contents of this FIR have been drafted  
upon my instructions. They have been read over to me  
in my vernacular and I affirm and understand the  
contents hereof.
