Sir,

In producing herewith one arrested accused person namely Pankaj Basak @ Totan (28 years) S/O Ananda Basak of Tikiapara, 1 No. Matangini Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized article vize-

- i) One improvised iron made fire arms in working condition measuring approx 08 inches from barrel to wooden butt having striking pin, hammer and trigger
- ii) One live ammunition engraved K F 8 MM unreadable on its percussion cap (found loaded in SI No 1) seized exclusively from the possession of accused person.

I, SI Uday Chakraborty of Siliguri Police Station, Siliguri police Commissionarate do hereby lodge this complaint that on 24.02.21 at around 18.55 hrs, received a secret source information that one person was moving suspiciously at D.L. Roy Sarani, Hill Cart road near Bata Goli more under Siliguri PS with an ulterior motive and is in possession of firearms. Dairsed the mater vide Siliguri PS GD entry no. 1387 dated 24.02.21. Accordingly I informed the matter to the I/C Siliguri PS and as per your kind instruction I along with ASI Siben Sarkar, ASI Subir Sen, C/971 Sanjay Roy CV/145 Bijay Das, all of Siliguri P.S. rushed to the place at D.L. Roy Sarani, Hill Cart road near Bata Goli more and on way picked up two disinterested witnesses namely (i) Md. Sahid (26) S/O Md. Nazir of Quareshi Mohallah, Ward No.06, PS-Siliguri, Dist- Darjeeling and (ii) Uday Das @ Maldiya (34) S/O Sudhir Das of Tikiayapara, Ward No. 18, PS- Siliguri, Dist- Darjeeling, duly informing them about the information in hand. At 17.25 hrs I along with force reached at D.L. Roy Sarani, Hill Cart road near Bata Goli more and after long time, as per identification by the source, myself along with force managed to apprehend the person. On being asked, the apprehended person disclosed his identity as noted above.

Accordingly, as per information and following all necessary procedures of search of the police person in presence of witnesses, search of the apprehended person Pankaj Basak @ Totan was made. On search one improvised iron made fire arms in working condition measuring approx 08 inches from barrel to wooden butt having striking pin, hammer and trigger and One live ammunition engraved K F 8 MM unreadable on its percussion cap which was found loaded in SI No. 1 was recovered, which was kept concealed under his Pant ,on the right side of his below the waist. On being asked about the possession of the firearm, the apprehended Pankaj Basak @ Totan made incoherent statements. On being asked he failed to produce any valid documents in respect of said Fire Arm. On further interrogation he stated that he had procured the said Fire Arm illegally with intend to sale under Siliguri area for his wrongful gain.

As there is every reason to believe that the firearm recovered has been procured dishonestly by the apprehended Pankaj Basak @ Totan for his ulterior motive, seized the firearm duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended Pankaj Basak @ Totan and arrested him following all formalities. The seizure has done between 20.35 hrs to 21.15 hrs.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested person namely Pankaj Basak @ Totan (28) S/O Ananda Basak of Tikiapara, 1 No. Matangini Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
