Sub - An intimation regarding my husband and in-laws ill behavior towards me.

Respected Sir/Madam,

It is to bring to your kind notice that my marriage was solemnized under Hindu Rituals and Customs on 05/02/2018 with Arnav Sinha, son of Achok Kumar Sinha, resident of Bagdogra, Vivekanandapally, Behind Maruti Tea Factory.

My father has incurred whopping amount of Rs. 30,00,000 (Rupees Thirty lakh) by fulfilling dowries (cash and non-cash) such as providing gold ornaments to groom, bride, relatives of groom, cash money to purchase furnitures, costly garments to groom and relatives of groom. He bore entire travel expenses by train, car, air tickets, luxury hotel/food for groom party stay and venue of marriage hall at Guwahati, ASSAM, as demanded by my husband (Arnav Sinha), mother-in-law (Priti Sinha), sister-in-law (Mita Sinha) and brother-in-law (Akash Singh). They refuse to solemnize the marriage at my parental home Silsasagar or Dehradun which incurred huge expenses.

Arnav Sinha, didn't attend reception party organized by my father in Dehradun to cause financial loss and humiliation in society.

Every now and then, they would forcibly send me to my paternal house after physical and mental harassment and blocked calls of my parents to establish no communication.

Several times my parents would come down with me to negotiate and agreed on car expenses for my husband to ease the marital tides and marriage.

Both mother-in-law and my husband physically assaulted me to force him to leave because that would fetch R.I. credit to them. (His job present sole income in their area).

Mita Sinha, Arinor Sinha and Priti Sinha has beaten me up on 25/12/2019 for dowry at 3:30 pm. This caused several injuries in my whole body as I was thrashed, pulled, clothes were torn, made half nude by them. I was forcibly driven out of house and kept in Construction Railway Rent House without medical treatment.

My mother and sister on being informed, gets me treated on 27/12/2019 at Siliguri District Hospital.

Arinor Sinha blackmailed/forced my sister on phone to take me back to ASSAM (parental home).

Akash Singh (brother-in-law) assassinated my character, questioned my chastity by outraging my modesty as a woman, objectified my body & several times.

I was discriminated for my language (Bengali dialect), commented on my looks, facial shape, body shape and slapped on face.

Priti Sinha would put up fight for several petty issues for S failed to give gold chain to her son at first night.

On stating directly by my mother to his mother, that we would have to approach police authority if they do not respond.

My husband received me back on 31/07/2020. He frequently started unnatural fights with me. I co-habited with him till 10/01/2021.

He forcibly takes me to rent house on 14/01/2021.

Meanwhile between 21/07/2020 and 11/01/2021, he gets signed from neighbors who got financial/non-financial help from him to show I am withdrawn from society.

After dumping me in rent house, he flew to Bangalore after that.

On my request he does my ticket on 18/01/2021 to attend my APDCL 2

During my stay in ASSAM, he sends me legal notice

Both mother-in-law and my husband physically assaulting me to force me to leave him.
because that would fetch R. 1 crore to them. (His job present role isigner

stating all false allegations and demand for mutual divorce
This is to serve their ill motive to defend them from offence they
committed against me.

Therefore, I pray / plead to take appropriate action against them herein
above mentioned names for offence they committed against me.
