I, Smt. Subhasree Saha, aged about 41 years, wife of Late Kamal Krishna Saha, house wife by occupation and permanent resident of Subhashpalli, Hati more, ward number 13 of SMC, P.O. & P.S. - Siliguri, Dist. - Darjeeling, beg to inform you that on 21/02/2000, according to Hindu rites and rituals I got married to Kamal Krishna Saha (since deceased), son of Late Bimal Krishna Saha, and I have a daughter out of the said wed lock.

In 2015, my husband died due to brain stroke and after his sudden death I continued to live with my in-laws at their residence as mentioned above along with my minor daughter. Just after three months of my husband's death, I was diagnosed with cancer and still I am under treatment. My in-laws did never bother to provide me a single penny either for my treatment or for our minimum livelihood. My mother in-law Smt. Mayarani Saha, wife of Late Bimal Krishna Saha, was never pleased to me as I gave birth to a female child. After my husband's death, my in laws started ill-treating me and my minor daughter Antara Saha saying that as my husband was no more, we did not have any right to stay at my-in-laws house. My mother-in-law forced me to handover all my golden ornaments to my brother-in-law, Sri Biplab Kumar Saha, who is running a medicine retail shop situated below our residential building, for further development of his business. Despite the above mentioned inhuman torture inflicted upon me, being a helpless widow and having a minor daughter, I kept my patience hoping that after few days the mentality of my in laws would change and everything would be normalised. But all my expectations went in vain. Being a cancer patient, I have to undergo through a huge and expensive medical treatment which became impossible for me to afford. Due to my physical condition, I am not even able to earn a little money to run my daughter's educational expenditure. My father even being an aged person, bears all my expenses out of his little savings, which was kept for his old age. My brother-in-law, Sri
