In producing herewith three accused persons namely 1) Ersad Hussain(25) S/O Habibur Rahaman of Tikiapara, Matangini Colony-II, Ward No.28, PS- Siliguri, Dist-Darjeeling, 2) Dilip Gupta (34) S/O Late Sambhu Sha of do and 3) Anil Paswan (50) S/O Late Charittar Paswan of do along with seized articles viz- 1) 35 (thirty five) bottles of "Chlorpheniramine Maleate & Codeine Phoshate Cough Syrup" styled as RBREXX containing 100 ml each having batch no. TBHT1949, Mfg date-10/2020, Exp date-09/2022 AMOUNTING of Rs.125/- and 2) one black color plastic bag to the effect that today i.e 27.02.21 at 15.35 hrs I received a secret information that three persons were busy to sell huge quantity cough syrup illegally to the young people at Tikiapara more near Over bridge under PS Siliguri. I diarised the matter Vide Siliguri PS GDE No. 1571 dated 27.02.21 and informed to I/C Siliguri PS. As per direction of I/C Siliguri PS myself along with ASI Subir Sen, ASI Siben Sarkar ,Const-917 Sanajy Roy, CV-145 Bijay Das and CV-622 Ramanath Barman left for Tikiapara more near Over bridge under PS Siliguri to verify the veracity of information vide Siliguri PS G.D.E no. 1572 dated 27.02.21. At about 15.45 hrs we reached at Tikiapara more near Over bridge under PS Siliguri under PS- Siliguri, Dist- Darjeeling. As per identified by source we managed to apprehend the above noted persons there by the help of local people.

In presence of the witnesses I found that the above noted three persons were busy to sale cough syrup illegally viz- 1) 35 (thirty five) bottles of "Chlorpheniramine Maleate & Codeine Phoshate Cough Syrup" styled as RBREXX containing 100 ml each having batch no. TBHT1949, Mfg date-10/2020, Exp date- 09/2022 amounting of Rs. 125/- in a plastic carry bag. I interrogated the above noted persons who disclosed their identity as noted above. On demand they could not produce any document in support to carry/selling the above noted Cough Syrup and confessed that they procures the same illegally with intension to sale to young people at Tikiapara more near Over bridge under Siliguri PS for their wrongful gain. So I Seized and labeled the above noted mentioned seized articles under proper seizure list in presence witnesses duly signed by the witnesses and arrested the above noted accused person u/s 41 Cr.PC after issuing Memo of arrest. The seizure and lable was made in between 20.15 hrs to 20.45 hrs.
