Respected Sir,

With due respect I, **SMT. SANGITA SAHA**, Wife of Sri Biswajit Saha, Resident of Vill.: Panchkolguri, P.O. Sahudangi Hat, P.S. N.J.P., Dist. Jalpaiguri, would like to lodge this written complaint before your good office to the effect that my husband Sri Biswajit Saha is the Secretary of Choto Bhai Sporting Club at Bhalobasha More, N.J.P., and everyday in the morning time, he used to visit the club premises to open the club room and switched off the electricity connection in the club premises. Today in the morning at about 9.00 to 9.30 A.M., my husband went to the club premises as usual course and when he was standing in front of the club premises, some miscreants and anti-socials numbering about 8 to 10 persons suddenly attacked upon my husband from the back side with sharp cutting weapons and other deadly weapons and the miscreants have also assaulted my husband brutally with the help of baseball bat, iron rod and other sharp cutting weapons and they have also carried fire arms in their possession and showed the said fire arms openly so that, nobody will dare to make any protest or to come near to the spot in order to rescue my husband and they have attacked and assaulted my husband brutally with an intention to murder him and when my husband became unconscious due to the severe assault of the miscreants, they have left the place. At the time of leaving the spot, they have again showed the fire arms openly so that nobody will dare to lodge any complaint against them and in fact, the adjacent peoples have saw the said incident but due to fear, they did not make any protest against them. Immediately after the said incident, when the miscreants left the place, the local peoples brought my husband at Dr. Maya Sanyal Nursing Home considering his severe injury and after receiving the said information, I also went there and found that my husband is in a unconscious condition and his condition is critical and struggling with life and death. **My husband has received severe injury on his head and every portion of his body and both the legs have been broken.** After preliminary treatment, when my husband regain his senses, he narrated me about the entire
