Sir,

In producing herewith (01) one arrested accused person namely Rakesh Das (22) s/o Bulu Das of Kankatta More, Eastern By Pass Road, Pengani Para, PS Bhaktinagar, Dist. Jalpaiguri along with following seized articles viz: -

1. One iron made improvised single shutter Firearms with body, trigger pin, barrel, wooden fitted butt and sling holder measuring length 26.5 cm (approx) diagonally which is packed, labeled and sealed and marked as "Exhibit-A".
2. One piece of live ammunition measuring 7.5 cm (approx) in length which is packed, labeled, sealed and marked as "Exhibit-B".

I, SI Sk. Tamzid Ali of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby lodge this suo-moto complaint against the above noted accused persons to the effect that on Dated 04.04.2022 at about 15.25 Hrs received a secret source information that one notorious criminal namely Rakesh Das of Kankatta More has possessed one firearms in his back waist with an illegal intention to commit crime in the area and is moving at Dasrath Pally, near Payel More under Bhaktinagar PS. Accordingly the information was intimated to I/C Bhaktinagar PS and noted the fact in vide Bhaktinagar PS GDE No-208, Dated 04.04.2022 and as per his direction, around 15.35 Hrs myself along with, PSI Sailesh Subba, ASI Rabin Lama, ASI Dipak Karmakar, C/374 Debraj Biswas, C/736 Mujibul Rahaman, CVF/935 Biplab Roy, CVF/619 Dharmendra Roy left PS to verify the veracity of the information. Before leaving from PS I took investigation kits. This refers to Bhaktinagar PS G.D.E No - 209, Dated 04.04.2022. Informed mobile van officer ASI Bimal Saha with a request to remain present at the above noted place for accompanying the raid team. On the way I briefed the accompanied team about the plan. At around 15.45 hrs I along with force reached Dasrath Pally and parked the vehicle at considerable distance and started moving towards the above noted place. On the way towards the spot seek available witnesses and requested them to remain present during raid and seizure if necessary. And I accompanied with my team and mobile van officer and forces started walking towards Payel More and being shown and identified by source we subsequently cordoned off the place and suspected person with a strong reason to believe that he may have possessed firearms in his possession for his illegal intention. After cordoning from all the sides I along with force approached towards the identified person and managed to apprehend and detained him. On being asked the detained person disclosed his name and address as Rakesh Das (22) s/o Bulu Das of Kankatta More, Eastern By Pass, Pengani Para, PS Bhaktinagar, Dist. Jalpaiguri. Further on being searched of his body found One iron made improvised single shutter Firearm with body, trigger pin, barrel, wooden fitted butt and sling holder measuring length 26.5 cm (approx) diagonally and One piece of live ammunition measuring 7.5 cm in length from his possession. Further on demand he failed to produce license or documents in respect of possessing the improvised firearms in his possession.

interrogation the detained accused person stated that he has procured the firearms along with live ammunition from Kishanganj area to deliver the same to local customer for his illegal gain. He also stated that he has been engaged in this illegal act since long for his wrongful gain.

I thereafter, packed, labeled and sealed and seized (1) One iron made improvised single shutter Firearm with body, trigger pin, barrel, wooden fitted butt and sling holder measuring length 26.5 cm (approx) diagonally which is packed, labeled and sealed and marked as "Exhibit-A". (2) One piece of live ammunition measuring 7.5 cm in length which is packed, labeled, sealed and marked as "Exhibit-B" under proper seizure list in presence of witnesses and acknowledged by the accused person. (The whole seizure and was made on 04.04.2022 in between 16.20 hrs to 16.45 hrs). Thereafter, I arrested the above noted detained accused person u/s 41 Cr.P.C under proper memo of arrest duly signed by the accused person. Accordingly brought the arrested accused person along with seized articles at Bhaktinagar Police Station for further investigation.


