Sir,

In producing here with the one arrested accused person namely Anu Lama (F/36) W/O- Diwas Lama of Upper Bhanunagar, Near Lions Club, PS- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

- 1] 12 (twelve) Bottles of Kingfisher Strong Premium Beer each Bottle Containing 650 ml.
- 2] 03 (three) Bottles of Royal Stag Deluxe Whisky each Bottle containing 375 ml.

I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 07.05.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No.370 Dated. 07.05.2022 at about 14.25 Hrs I, received source information that the above noted accused person have possessed huge amount of Liquor carrying in a carrying bag at near Lions club, upper Bhanunagar area under Bhaktinagar PS for the purpose of selling the same to local customers. Accordingly the information shared before you and as per your kind direction I along with ASI Nitai Mandal, Constable C/986 Rajib Sarkar, LC/1348 Menuka Rana, CVF-014 Labanyamoy Barman headed towards near Lions club, upper Bhanunagar area to verify the veracity of the information. we reached at near Lions club, upper Bhanunagar area and as shown and being identified by the source held raid and apprehended one person who disclosed her identity as noted above. Further maintaining her decency and observing all formalities searched her and recovered huge amount of above noted seized liquor with one carrying bag from her possession. On demand she could not produce any valid documents/licence in respect of the recovered liquors. On enquiry the apprehended persons admitted her guilt and confessed that she has possessed above noted liquor at her house for the purpose of selling to her designed customers. She also stated that she has been doing this illegally since long without any valid licence or Documents for her wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 15.05 Hrs to 15.40 Hrs. As she has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising her the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Anu Lama (F/36) W/O- Diwas Lama of Upper Bhanunagar, Near Lions Club, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
