Sir,

With due respect I Sri Rajesh Patel, Son of Satya Naryan Patel, resident of Biswakarma Mandir Road, Near Paramount Nursing Home, P.O. Siliguri Bazar, P.S. Khalpara TOP under Siliguri Police Station, Dist. Darjeeling, beg to lodge this written complaint against the accused person namely Uday Jaiswal, Son of Late Jadu Jaiswal, resident of Jaiswal Bhawan, Opp. Arogya Niketan Nursing Home, Khalpara, P.S. Siliguri, Dist. Darjeeling.

That I alongwith my wife and 4 (four) years old son was a tenant under the above named accused person Uday Jaiswal since 01.03.2020 at monthly rent of Rs.12,000/- (Rupees Twelve Thousand) and I also paid Rs.40,000/- (Rupees Forty Thousand) as an advance to said Uday Jaiswal. During lockdown due to good relation Uday Jaiswal often came to my house. And 25.06.2021 when my wife alone said Uday Jaiswal hagged her forcefully, when my wife tried to stop him Uday Jaiswal thrown my wife in the ground and injured her. On that day when I made protest against his illegal act then said Uday Jaiswal tried to throw my 4 (four) son from the roof of the third floor building and I begged for my son's life. Due to tremendous torture I and my family compelled to vacate the tenanted premises. In spite of that Uday Jaiswal did not recede me. That on 28.04.2022 at about 11:00 a.m. said Uday Jaiswal called me by a terrorist Mobile Phone No.8536080054 in the guise of a CBI Officer and threatening me to kill me and my family members.

That on 19.05.2022 my friend was organized a marriage party at Uttarbanga Marwari Palace at Sevoke Road, Siliguri and I went there. At that time said Uday Jaiswal suddenly came to the marriage party and he started to quarrel with me there and not to ruin anyone's programme I left the Uttarbanga Marwari Palace and came on Sevoke Road and getup in a Toto. Then suddenly said Uday Jaiswal and run and pulled me out of the Toto. Somehow, I managed to leave from there but said Uday Jaiswal started to insult me with obscene languages and threatened me that if I do not settle with him, he will shoot me and my family members within 24 hours. Not only that said Uday Jaiswal was also threatened me that he do not allow my family members and my in-laws to stay in Siliguri. I alongwith my family members are terrified due to the illegal activities of said Uday Jaiswal. Uday Jaiswal is a dangerous and desperate antisocial person and he may kill me and my family members at any opportunate moment.

Please save me and my family members from the hand of said Uday Jaiswal. Finding no other alternate I came before you for your help and support.

Under the above circumstances, I would request you please investigate that matter and punish the accused person Uday Jaiswal according to law.

Hope to be favoured with your kind and necessary co-operation.
