
I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do hereby lodge this complaint against Smt Babita Paswan, W/O Lt Lakshman Paswan, Resident Of Vill Paswan Basti, Near- Udit Ujjala Club, Po-Sevoke Road, P.S Bhaktinagar, Dist Jalpaiguri, West Bengal. While on a routine inspection on the site having consumer id 412257933, meter no H249451, having power connection by WBSEDCL in the name of Smt Babita Paswan in the address being Vill Paswan Basti, Near- Udit Ujjala Club, Po-Sevoke Road, P.S Bhaktinagar, Dist Jalpaiguri, I, Suman Sengupta, Divisional Engineer & Station Manager, Power House CCC along with Sanjay Prasad, Sr Office Executive, Power House CCC, WBSEDCL and other technical staffs observed that the energy meter has been damaged and the terminal seal was found broken and power was being used from the damaged meter.

We entered the premises at 1758 hrs on 26.05.2022 after handing over Notice to Smt Babita Paswan. Then it was observed that the terminal seal of the meter was missing and the meter was shifted from its original place un authorized by damaging the meter bearing meter no H249451. Therefore committing a crime for theft of power as per section 135 (1) (c) & 136 (1) (c) of the Electricity act 2003 amended on 2007 of India. Accordingly the connection was disconnected and the service cable was seized and labelled. A copy of both inspection report and Seizure list (1. 1nos of energy meter, Himachal make, 240V, 5-30amps, SI No H249451, L/R- 8785 & 2. Service cable, Single Core, 6Sq mm, Aluminium, Red and black in colour of 3 meters approx) were handed over to Smt Babita Paswan. We exited the premises on 1815 hrs.

Thus you are requested to kindly initiate an investigation against Smt Babita Paswan under Section 135 (1) (c) & 136 (1) (c) of the Electricity act 2003 amended on 2007 of India.
