I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpura CCC, WBSEDCL, Siliguri do here by lodge complaint against Manik Chandra Dey (Present user), S/O- Lt. Madhab Ch.Dey, Fuleswari Unnayan Colony II, Subhaspally, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 30.05.2022 at about 03.30 p.m. acting on a source information I, along with 1) Sri Malay Kr. Goswami, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpura CCC and other officials of WBSEDCL entered the residential building of Manik Chandra Dey (Present user) and inspected service installation, metering installation of Consumer ID 412027618 in the name of Lt. Madhab Ch.Dey. During inspection it was found that electricity was being used unauthorisedly & illegally for commercial purpose from domestic connection.

As unauthorised commercial uses from domestic service connection was detected the energy meter make HPL-SOCOME Pvt Ltd, serial no.- P1926074 installed against Con Id. 412027618 seized by preparing a formal seizure list duly signed by representative of Manik Chandra Dey and witnesses. The copy of the seizure list handed over to representative of Manik Chandra Dey and his signature obtained as token of receipt.

As Manik Chandra Dey have committed offence u/s 135(1)(e) of Electricity Act 2003 by using electricity illegally & unauthorisedly for commercial purpose from domestic connection, you are requested to take cognizance of the same by treating this complaint as FIR.
