In producing here with the one arrested accused Kamal Lama (54 yrs) s/o- late Inju Lama of Subash Pally Bagrakot near Food supply office ward no 18, PS- Siliguri Dist- Darjeeling along with Eleven (11) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-)

I ASI Rabin lama of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Kamal Lama (54 yrs) s/o- late Inju Lama of Subash Pally near Food supply office ward no 18, PS- Siliguri Dist- Darjeeling to the effect that on 04/07/2022 during my mobile van duty (vide Siliguri PS GDE no 232 dated 04/07/2022) I received a source information at about 17.25 hrs from Subash pally, Bagrakot, ward no 18 under Siliguri PS, that one Kamal Lama, of Subash pally, Bagrakot, is selling huge quantity of liquor illegally at Subash pally near Food Supply office to his design customers since long, for his wrongful gain. After sharing the information with I/C Siliguri and as per his kind direction, I along with ASI Siben Sarkar, ASI Debasish Das, CV/263 Prasenjit Dey proceeded to the P.O to work out the source information. At about 17.45 hrs I along with my police team reached at Subash pally, near Food Supply office ward no 18, on being identified by the source our police team held raid against the above noted person and managed to apprehended the said person, and recovered Eleven (11) sealed bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, which was conceal on the road side. On interrogation he disclosed his identification as Kamal Lama (54 yrs) s/o- late Inju Lama of Subash Pally Bagrakot near Food supply office ward no 18, PS- Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or license in r/o said liquor, accordingly I seized the same viz; Eleven (11) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-) from the possession of Kamal Lama (54 yrs) s/o- late Inju Lama of Subash Pally Bagrakot near Food supply office ward no 18, PS- Siliguri Dist-Darjeeling (seizure and labelled was made between 17.50 hrs to 18.35 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Kamal Lama (54 yrs) s/o- late Inju Lama of Subash Pally Bagrakot near Food supply office ward no 18, PS- Siliguri Dist-Darjeeling under proper section of law.
