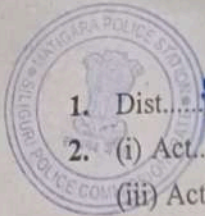

Sir,

In producing herewith the arrested accused person namely (i) Anil Sha (25 yrs) S/O Sri Binod Sha of Hemanta Basu Colony, Ward No-04, PS- Siliguri, Dist.- Darjeeling and (ii) Rajesh Singha (26 yrs) S/O Ranjit Singha of Boro Rajajhar Jote, PO- Ranidanga, PS- Bagdogra, Dist.- Darjeeling and the following articles under seizure. The ground of arrest duly been communicated with him.

1. One Motor Cycle displaying number plate WB/64/J/6708 (Honda CBR) having Chassis No ME4KC182LD8011306.
2. One motor cycle displaying number plate WB/74/AJ/7254 (Super Splender) having Chassis No MBLJA05EME9M14164 Engine No JA05ECE9M13685.

I, SI Goutam Mallik of Matigara Police PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused Persons namely (i) Anil Sha (25 yrs) S/O Sri Binod Sha of Hemanta Basu Colony, Ward No-04, PS- Siliguri, Dist.- Darjeeling and (ii) Rajesh Singha (26 yrs) S/O Ranjit Singha of Boro Rajajhar Jote, PO- Ranidanga, PS- Bagdogra, Dist.- Darjeeling to the effect that on 27.07.2022 at 16.35 hrs I received reliable secret source information that two persons came at New Chamta near Mayfair Hotel with two numbers stolen motor cycle with a view to sale the same to their customers. Accordingly, I diarized the matter in General Diary vide Matigara PS GDE No 1936 Dated 27.27.2022 and informed the fact to the Officer -In-Charge, Matigara PS and as per his kind order and direction myself along with PSI Shekhar Adhikary, PSI Agen Lepcha, ASI Dharendra Nath Mandal, C/1053 Paresh Rava and C/974 Mintu Sen all of Matigara PS left for New Chamta near Mayfair Hotel by Govt vehicle to verify the veracity of the information. At about 17.05 hrs we reached at New Chamta near Mayfair Hotel and from a considerable distance we noticed that two persons were standing with two motor cycle at New Champta Road near Mayfair hotel. Seeing the police party they started to flee away toward tea garden keeping their motor cycle on the road but after a hot chase we able to apprehended both them. On being asked they disclosed their identity as noted above. On demand they failed to produce any documents in respect of the motor cycles found in their possession. On interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with motor cycles. During further interrogation they disclosed that they have stolen the said two motor cycles and came their to sale the same to their design customers. There was sufficient reason to believe that the said two motor cycle are stolen one. Accordingly, I seized the above noted two motor cycles under proper seizure list and arrested them under proper memo of arrest and observing all the formalities of arrest. The search seizure made in between 17.55 hrs and 18.45 hrs on 27.07.22.

Under the above noted fact and circumstances, I therefore pray to you that a specific case under proper section of law may kindly be registered against accused namely (i) Anil Sha (25 yrs) S/O Sri Binod Sha of Hemanta Basu Colony, Ward No-04, PS- Siliguri, Dist.- Darjeeling and (ii) Rajesh Singha (26 yrs) S/O Ranjit Singha of Boro Rajajhar Jote, PO- Ranidanga, PS- Bagdogra, Dist.- Darjeeling and arrange for its investigation.
