Sir,

In producing herewith four(04) arrested accused persons namely (i) Md.Riyaz(28/M) S/O Lt. Md Islam of Gowalapatty, near Shani Mandir, W/No – 04, PS. Siliguri, Dist. Darjeeling (ii) Gopal Mandal(28/M), S/O- Gyanada Mandal, of Subash Pally, Lechubagan, W/No-18, PS. Siliguri, Dist. Darjeeling, (iii) Bikey Sahani(22/M), S/O Lt.- Kapil Sahani of Tikiapara, Majdoor Colony, W/No-28, PS. Siliguri, Dist. Darjeeling (iv) Promod Sahani(25/M) S/O Akhil Sahani of Tikiapara, Majdoor Colony, W/No-28, PS. Siliguri, Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

i. One iron made 'Katari' measuring 24 inch (approx) including wooden butt from the possession of Md.Riyaz which was kept concealed on his back side,

ii. One iron made sword measuring 35 inch (approx) including wooden handle from the possession of Gopal Mandal which was kept concealed on his back side,

iii. One Iron made rod measuring 40 inch (approx) in length from the possession of Bikey Sahani which was kept on his right hand,

iv. One iron made sword measuring 30 inch (approx) including wooden butt from the possession of Promod Sahani which was kept concealed on his back side,

I, ASI Siben Sarkar, S/O- Raghupada Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Md.Riyaz, (ii) Gopal Mandal, (iii) Bikey Sahani, (iv) Promod Sahani and others namely Toton, Nandu, Rabi, Binod and Kalam to the effect that today on 11.08.2022 at 00.25 hrs received a sources information that 10/12 youths have assembled behind Polytechnic College, Dabgram - 1, under Siliguri PS with a view to commit dacoity at Dabgram area. The fact was diarized in GD vide Siliguri PS GDE No-638 dated 11.08.2022. Subsequently, after sharing the information with I/C Siliguri PS and as per his direction, I along with ASI Rabin Lama, ASI Debasish Das, CV/283 Prasanjit Dey and CV/622 Ramanath Barman left for the place to work out the information. At about 00.55 hrs after reaching Polytechnic College under PS- Siliguri I met my source and as pointed by the source we started walking towards behind Polytechnic College. At 01.15 hrs we reaching behind Polytechnic College started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted four(04) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of undulating ground. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Dabgram area.

ASI Siben Sankan Siliguri ps/SPC St. 11.08,22 I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.25 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrest duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Dabgram area. It is also revealed from them that Toton, Nandu, Rabi, Binod and Kalam and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Md.Riyaz(28/M) S/O Lt. Md Islam of Gowalapatty, near Shani Mandir, W/No - 04, PS. Siliguri, Dist. Darjeeling (ii) Gopal Mandal(28/M), S/O- Gyanada Mandal, of Subash Pally, Lechubagan, W/No-18, PS. Siliguri, Dist. Darjeeling, (iii) Bikey Sahani(22/M), S/O Lt.- Kapil Sahani of Tikiapara, Majdoor Colony, W/No-28, PS. Siliguri, Dist. Darjeeling (iv) Promod Sahani(25/M) S/O Akhil Sahani of Tikiapara, Majdoor Colony, W/No-28, PS. Siliguri, Dist. Darjeeling, and (v) Toton,(vi) Nandu,(vii) Rabi, (viii) Binod, (ix) Kalam and others and arrange for its investigation.
